I am pleased to approve, on varied terms to what was in the application, Port Phillip City Council's request to enter into a contract with Four Seasons Waste Pty Ltd for the following services:

- Residential Kerbside Waste Collection
- Residential Kerbside Recycle Collection
- Hard Waste and Dumped Rubbish Collection

Enclosed is the instrument of approval allowing Council to enter into a contract at any time from the date of approval until 30 June 2022 (inclusive).

I note the council's advice that the proposed arrangement will allow for alignment of the contracted collection services with implementation of the kerbside systems required under the Recycling Victoria policy.

The *Local Government Act 2020* removes the requirement for councils to seek exemptions from procurement requirements from 1 July 2021. After this time, councils will be required to comply with their procurement policies, which must be in place by 31 December 2021.
