

Each item has a report written by a Council officer outlining the purpose of the report, all relevant information and a recommendation. The Committee will consider the report and either accept the recommendation or make amendments to it. This Committee has delegated authority. A recommendation is carried if it receives majority support of the Councillors in attendance at the Committee meeting.

Public Question Time and Submissions

Public Question Time Provision is made at the beginning of the meeting for general question time from members of the public concerning planning matters.

Members of the public have the option to either participate virtually via WebEx to ask their questions live during the meeting. Submitters who cannot contribute to the meeting either in person or virtually may have an officer read their statement on their behalf. Please note statements will be summarised when read by an officer, to assist with meeting process.
