Terms and Conditions:

- The City and/or its agents is/are authorised to enter upon the premises and to eliminate graffiti from all exterior walls and other surfaces in such a manner as the City determines.
- All graffiti elimination work shall be co-ordinated with the operations of the Owner wherever possible and all necessary precautions will be taken to safe guard the Owner's property.
- The Owner hereby:
 - Releases the City and/or its authorised agents from any and all claims and liability for injury or damage, of whatever kind or nature, resulting from City's entry upon and use of the premises;
 - Waives any claim for property damage or for any bodily injury that the Owner has or may have against the City resulting from the activities undertaken by the City pursuant to this right of entry;
 - Indemnifies and holds harmless the City from and against any and all claims, loss, damage or liability of whatever kind arising in any manner out of the activities permitted hereunder in, on or about the Premises.
 - Understands and agrees that this permitted entry shall not create an on-going obligation by the City to remove graffiti from the Premises.
- All graffiti elimination work done by the City and/or its authorised agents pursuant to this Right of Entry shall be performed at the sole discretion of the City, at no direct cost to the Owner and subject to resources and availability to the City.
- The Right of Entry shall remain in full force and effect until rescinded in writing by Owner.
