



# Report and consent: Erection of precautions over the street alignment

## What you need to do



### Complete the form

Make sure all sections are complete and you have supplied all supporting documents.



### Submit application

This form and supporting documents must be submitted via email or by mail.



### Receive your invoice

Once your application is processed you will receive an invoice within two working days.

## Read before starting

Below are some things people often miss when submitting their application. Making sure you include this information will prevent delays and save you time.

### Documents to be provided

In order for your application to be assessed, this form must be accompanied by:

- **one copy of a site plan layout** that clearly shows the following:
  - The area of the footpath/road that is to be occupied by the hoarding.
  - The height and type of hoarding that is proposed.
  - The dimensions of the area of the footpath/road that is to be occupied by the hoarding.
  - The minimum clearances to be provided adjacent to the perimeter of the hoarding (i.e. minimum 1.5 meter clearance for pedestrian access).
  - If the property is located on a declared road, provide the approval of Vic Roads. A list of declared roads can be found on [vicroads.vic.gov.au/traffic-and-road-use/road-network-and-performance/maps-of-declared-roads](http://vicroads.vic.gov.au/traffic-and-road-use/road-network-and-performance/maps-of-declared-roads)

- **a letter from the relevant building surveyor** for the project detailing and consenting to the proposed method of public protection/precautions that are to be erected over the street alignment.
- **a sectional detail of the proposed gantry.** The sectional detail is to include the method of support to ensure lateral stability. Please note that no part of any support or restraint is to encroach beyond the face of the gantry (ie concrete base or the like).

### Street Occupation Permit

Prior to any protection works or safety precautions being constructed over the street, road or footpath, a Street Occupation Permit must be obtained from Council. For information about how to obtain the permit, please contact the Development Permits team on 03 9209 6216.
