PURPOSE

To endorse the City of Port Phillip's participation in the 'Cities Power Partnership' a program of the Climate Council that is launching on 19 July 2017.

1. RECOMMENDATION

That Council:

- 1.1 Endorses the City of Port Phillip's participation in the 'Cities Power Partnership'.

2. BACKGROUND

- 2.1 The Cities Power Partnership (Partnership) is a program of the Climate Council that is launching on 19 July 2017.
- 2.2 The Climate Council provides independent, authoritative climate change information to the Australian public that is based on the best science available. It is an independent not-for-profit organisation, governed by six Climate Commissioners – including Tim Flannery.
- 2.3 In 2016, the Climate Council was the primary organisation communicating information regarding climate change nationally and reached eight million people per month online.
- 2.4 The Partnership provides a coordinated vehicle to accelerate, celebrate and promote local government successes in achieving emission reductions and transitioning towards clean energy.
- 2.5 There are no costs for councils to join the Partnership.
- 2.6 Twenty one councils have already signed up to the Partnership in the first round, with these councils from around the country. There are four vacancies remaining in the first round.



3. KEY INFORMATION

Benefits of joining the ‘Cities Power Partnership’

- 3.1 The opportunity to enhance the City of Port Phillip brand as a Council committed to addressing Climate Change.
- 3.2 Social Media promotion and a website profile. This will increase public awareness of Council’s Integrated Council Plan as sustainability and renewable energy success stories are shared with over 200,000 Climate Council supporters.
- 3.3 Access to the Partnership knowledge hub, webinars and potential direct access to Climate Council experts.
- 3.4 Access to an analytics tool to track and measure savings in greenhouse gas emissions, energy savings to date and financial savings to date of specific sustainability, clean energy and efficiency projects.
- 3.5 An invitation for the Mayor to participate in the media and stakeholder launch of the Cities Power Partnership (the Partnership) on 19 July in Canberra.
- 3.6 Invitations to attend the 2018 Partnership summit and awards ceremony with other councils across the country.
- 3.7 Potential access to exclusive grants and incentives to support renewable energy, energy efficiency and sustainable transport goals as they become available.

Requirements of joining the ‘Cities Power Partnership’

- 3.8 Council will be required to nominate five action items in the Power Partners Pledge.
- 3.9 There is a six month period allowed before committing to the pledges. Officers have identified five pledges that align with the Integrated Council Plan, as outlined in the table below.

- 3.10 Officers will complete a six monthly online survey that provides the Climate Council with basic information on how Council is progressing on the five action pledges. This can be achieved within the current Sustainability and Transport operational budget.
- 3.11 A point of contact (the Coordinator – Sustainable Programs) will be provided so that the Climate Council can liaise with on Partnership matters.
- 3.12 Collaboration with two other local councils to facilitate knowledge sharing.



FURTHER SUPPORTING INFORMATION

4. ALIGNMENT TO COUNCIL PLAN AND COUNCIL POLICY

- 4.1 Membership of the 'Cities Power Partnership' aligns with Direction 3 "We have smart solutions for a sustainable future'. Specifically, it will support outcome 3.2 'A City with lower carbon emissions'

5. CONSULTATION AND STAKEHOLDERS

- 5.1 Prior to developing this recommendation, officers attended an information session and presentation with the Climate Council and other interested local government representatives.
- 5.2 Consultation also occurred across the Sustainability and Transport Department to confirm that suggested Action Pledges are achievable and that the reporting requirements can be managed within existing officer resources.

6. LEGAL AND RISK IMPLICATIONS

- 6.1 Joining the 'Cities Power Partnership' does not expose Council to any legal risk.
- 6.2 There is a reputational risk if Council fails to make progress on the Action Pledges. This risk is mitigated through the careful selection of pledges that are already priority actions within the Integrated Council Plan and have sufficient resource allocations to support success.

7. SUSTAINABILITY – Triple Bottom Line

7.1 ENVIRONMENTAL IMPLICATIONS

- 7.1.1 Achieving the Action Pledges in the 'Cities Power Partnerships' will reduce the Greenhouse gases released into the atmosphere by both Council and the Community.

7.2 FINANCIAL IMPLICATIONS

- 7.2.1 Membership of the 'Cities Power Partnership' comes at no cost. The reporting requirements can be managed within the existing Sustainability and Transport departmental staffing budget.
- 7.2.2 Achieving the Action Pledges requires investment by Council. However, each pledge is already planned and budgeted within the *Integrated Council Plan* and Budget.

8. IMPLEMENTATION STRATEGY

8.1 TIMELINE

- 8.1.1 5 July 2017 – Council endorse membership of the 'Cities Power Partnership'
- 8.1.2 19 July 2017 – Official launch of the program with the 25 partner Councils in Canberra
