

## **Rebates and Incentives**

**State Government: Solar Victoria Rebate** 

Property valued at less than \$3 million

Combined household income of less than \$180,000

Are the owner-occupier and do not have an existing system, then...

You can receive up to \$1850 rebate off your Solar PV system and \$1850 nointerest loan over 4 years

OR receive \$1000 rebate for Solar Hot Water: <u>www.solar.vic.gov.au</u>

And, the solar pv rebates are available to landlords/renters

## Solar Victoria Rebate

- 1. To register, contact YEF or online at <u>www.portphillipsolar.org.au</u>
- 2. Past 12 months of bills and note your NMI number
- 3. Visit <u>www.solar.vic.gov.au</u> to apply. You will need: Your Eko Energy quote, Council Rates Notice, 2 forms of ID, ATO Notice of Assessment or Centrelink Payment Summary
- 4. You can apply for interest-free loan (\$1,850)

5. Receive email of approval from Solar Victoria, then contact Eko Energy to confirm that you're proceeding and confirm the install date

6. Four to six weeks after install date confirmation, your solar is installed and you can now enjoy reduced bills!!!

## Heritage Overlay

Heritage Overlay does not always prevent rooftop solar installations.

A Planning Permit is required if the panels will be visible from the street (other than a lane) or a park. Council will waive the permit fees and will process the application minimising paperwork requirements and processing time.

A Planning Officer will assess your application with advice from Council's Heritage Advisor they may suggest changes to the sizing or placement.


