



# Report and consent: Flood prone areas/designated land or works

## What you need to do



### Complete the form

Make sure all sections are complete and you have supplied all supporting documents.



### Submit application

This form and supporting documents must be submitted via email or by mail.



### Receive your invoice

Once your application is processed you will receive an invoice within two working days.

## Read before starting

Below are some things people often miss when submitting their application. Making sure you include this information will prevent delays and save you time.

If a planning permit is required for the construction of the building and the relevant planning scheme regulates the level of the lowest floor of the building in relation to any flood level declared under the Water Act 1989 or otherwise determined by the floodplain management authority or the relevant council then this Report and Consent is NOT required to be sought from the Municipal Building Surveyor.

### Documents to be provided

In order for your application to be assessed, this form must be accompanied by:

- **one set of plans for the work** including a site plan and elevations and showing all finished floor levels and finished external surface levels. Note that levels to Australian Height Datum are required
- **a full copy of title** including a plan and a copy of any covenants or agreements listed on the title.
