Welcome

As I enter my second month as CEO I am pleased to present this report outlining Council activities and performance. This report is designed to provide transparency about Council's activities and highlights some of the many ways Council services and advocacy make a difference in our community.

Delivering the Council Plan

Fishermans Bend Urban Renewal Area

In June, Council officers presented to the Ministerial Advisory Committee on the role and function of precinct planning.

Officers continue to provide input into the work of the Fishermans Bend Taskforce including the draft Fishermans Bend Framework Context Report and Implementation Plan and revised planning controls. It is understood that this will be put to the State Government prior to providing for councillor feedback with public consultation scheduled for later in the year.

Ferrars Street Education and Community Precinct

I had the pleasure of touring the South Melbourne Ferrars Street Primary School construction site on 16 June with the school principal Noel Creece and representatives from the Victorian School Building Authority and the Fishermans Bend Taskforce. It's fantastic to see the building progressing on schedule and to see Council's facilities like the consulting rooms, multipurpose rooms and sports courts start to take shape.

During June Council's contractors started the demolition of the building at 2-4 Buckhurst Street, which will become the new Montague Community Park. The detailed design will be finalised over the coming months and the park is due to open in mid-2018.

We've also opened our centralised childcare waiting list to families seeking a place for their child at the new Ferrars Street long day care kindergarten in 2018. Located on the top floor of the South Melbourne Ferrars Street Primary school building, the kindergarten will have 44 long day care places for three to four year olds.

St Kilda Triangle

During June officers worked with Councillors to plan the next steps for progressing the plans for St Kilda Triangle and possible planning scheme amendment.

Preparation for the winter activation of St Kilda Triangle site progressed with Map 57 - St Kilda's Winter Garden opening on 15 June. Running until 30 July, the unique festival will transform the site into a glittering winter garden, playing host to a pop up ice rink, comedy, theatre, music, food stalls, carnival rides and more. Palais Theatre

The Palais Theatre is back in operation for an exciting program of shows. Phased works by Live Nation are being undertaken between shows to deliver their major program of internal heritage restoration and upgrade works.

Specialists have recently installed the Palais Theatre's new carpet. Its pattern is an exact re-creation of the 1927 original, and crafted in England by the Royal Warrant carpet manufacturer to Her Majesty the Queen - supplying Buckingham Palace and other Royal households.

This gloriously rich, elaborate carpet is one of the Heritage Victoria conditions of permit approval.

Vibrant places and villages

A key objective of the Port Melbourne Waterfront Activation Plan was to establish the Waterfront Welcomer program, which launched in October 2014. The program aims to deliver local information about businesses, activities, attractions and events during the October-May cruise ship season to assist and welcome cruise passengers and crew.

The third successful season of the program came to a close on 23 May with the departure of the Sea Princess. This season volunteers warmly greeted and welcomed 8,446 passengers from 47 ships to Port Melbourne, and the City of Port Phillip with volunteers donating 723 hours to the program.

The program is led by the community with a partnership of supportive key stakeholders including the City of Port Phillip, Inner South Community Health, Port Melbourne Neighbourhood Centre, Port Melbourne Business Association, and Victorian Ports Corporation Melbourne. The cruise segment has been identified as a the fastest growing sector of the tourism industry, with 114 cruise liners scheduled to dock at Station Pier in the coming 2017/18 season.

Toward Zero implementation

On 9 May Council hosted an information free session about installing solar photovoltaic systems at home. Presented by Green Moves Australia's Danielle King, discussions covered types of solar systems, costs, estimated payback and feed-in tariffs, installation and connection to the grid, ongoing maintenance, current battery storage system technology, and suitable locations on buildings in heritage areas.

On 20 May we partnered with Smart Blocks, Yarra Energy Foundation, Alternative Technology Association and the cities of Melbourne and Stonnington to host the third annual High Life Expo. The expo provided over 45 stalls with information on the latest sustainability products and advice from selected suppliers and technical experts.

Gasworks Arts Park remediation

Soil analysis for Gasworks Arts Park continued throughout May. Once the soil samples have been analysed, the independent auditor will develop an appropriate solution for the park. This will guide decision making for the management of the contaminated soil.

South Melbourne Life Saving Club

An expression of interest process to procure a builder commenced in June.

JL Murphy Reserve pavilion

The draft concept design of the sports pavilion is being finalised and will be presented to the community in July.

Peanut Farm Reserve and pavilion upgrade

Council continues to work with Sport and Recreation Victoria regarding a potential change of direction, or funding, for the project. **This text will be updated if new information becomes available before report is published.**

Queens Lane precinct

All road resurfacing of Queens Lane and side streets have been completed. Site inspections in May determined that several underground services may impact potential tree locations in Queens Lane so officers are investigating alternatives and opportunities for tree planting in the precinct. Planting is anticipated to occur in late June.

St Kilda Road safety improvement project

The Mayor and officers met with the CEO of VicRoads in late May and VicRoads confirmed it aims to deliver the project by December 2018.

Council continues to work with VicRoads on the design of the safety improvements identifying appropriate measures to manage local transport and parking and ensuring the community has opportunity to engage on specific aspects of the project design and management measures.

Growing affordable housing in Port Phillip

In May strategic direction was provided on progressing the proposed Marlborough Street housing project under the Port Phillip Housing Trust and continuing development of a new trust model. Council officers are working with Port Phillip Housing Association (PPHA) to generate a proposal for the project, and over the next few months PPHA will undertake preliminary design and financial feasibility.

In relation to the work of the In Our Backyard Taskforce, a proposal request was prepared for Council to facilitate a process with property owners and housing associations for the temporary use of vacant residential housing to help create a 'pop-up vacancy chain' and assist the management of tenancies for longer-term housing projects. Officers also met with key agencies to ensure supporting works and funds align with the project and incorporate social

enterprise outcomes. The content of a funds booklet (prospectus) to attract funding from philanthropic foundations was finalised in May and a draft design will be available in late June prior to its launch in 2017/18.

An internal workshop was held in June to discuss ways to align the implementation of the In Our Backyard 10 year strategy (focusing on years one to four) with opportunities for increasing affordable housing under the State Government's Homes for Victorians policy, Plan Melbourne and the Fishermans Bend planning controls. This included opportunities for increasing the dwelling yield on existing social (public and community) housing sites, building on preliminary investigation undertaken by Council officers in May, and preparations for designing the expression of interest process in 2017/18 relating to the future development of community housing on Council land / air space.

Improving community value

Continuous service and business improvement

We recently started working with the community to develop a plan to improve customer experience. The improvement plan will use customer research and insights to drive improved customer service, technology investment, and service delivery improvements that will deliver increased customer satisfaction. The plan will be finalised in July.

Enterprise portfolio management

During May work commenced on improvements to the current Project Guidance System, the tool used by the City of Port Phillip to plan, monitor and control projects. This work will take us through to the end of the financial year and will focus on improvements to design and layout of the system and introduce new capability, such as benefits management. Information sessions for Council employees covering all changes made to the Project Guidance System commenced in June and will continue through to July.

Aligned organisational culture and capability

The 2017 Staff Survey was administered over a two week period from 15 to 26 May with results anticipated in late June. Work also began to implement the 2016 Enterprise Agreement with all back payments made on 23 May.

In June, the end of year performance review for employees commenced. Officers also worked towards a business case for a new learning management system. Implementation of the new system is anticipated to commence in October.

Good governance

Council continued to build transparency and community engagement through live streaming the 7 June Council meeting at the Port Melbourne Town Hall. Live streaming enables those who are unable to attend Council meetings to access Council decision making. Councillors attended the Municipal Association of Victoria State Council on 12 May. The City of Port Phillip had two motions moved in relation to aligning VCAT decisions with community expectations and cost shifting from state to local government. On 17 May Council moved a motion to reaffirm its commitment to reviewing the heritage protection of social significant places across the municipality that are currently not covered by a Heritage Overlay. Council also acknowledges that recent requests for heritage protection of the London Hotel and Greyhound Hotel have highlighted a lack of clear statutory guidance regarding the threshold for local social significance. Integrated Council Plan 2017-27 adopted

On 21 June Council adopted its Council Plan which is significant milestone for this Council.

Council Plan 2017-27 is the first plan to be integrated with our Municipal Public Health and Wellbeing Plan, Strategic Resource Plan and annual budget. Achieving an integrated plans is quite rare across Victorian municipalities, and importantly it links activities, spending, performance management and accountability with the outcomes the Council wants to achieve over the next ten years.

Council Plan 2017-27 is a courageous, community focused, progressive plan built upon the enduring commitment of Councillors, staff and the Port Phillip community.

Back in November 2016, one of the first activities of the newly elected Council was to agree on what they wanted to achieve in their four-year term. Councillor's expressed a strong commitment to engage with the community and ensure their vision was truly representative and responsive to that of a growing city.

In early 2017 officers supported the realisation of Council's vision through the design and delivery of an extensive community and stakeholder engagement program. This model was Council's most successful yet and generated over 2,000 pieces of community feedback. A staff expo in May ensured the organisation played its part in shaping and informing the plan.

Embedded in this plan is our financial strategy. The challenge of rate capping means without action, we face a cumulative funding \$35 million gap over the next 10 years. This plan addresses this gap by:

- delivering \$2 million permanent operational savings in 2017/18, adding to the \$7 million delivered in the last three budgets and targeting ongoing efficiency savings that will reduce our cost base by a cumulative \$22.5 million over the 10-year period.
- appropriate use of borrowings and reserves
- careful management and prioritisation of expenditure, and
- setting fair and appropriate user charges.

I want to thank all staff who have been involved in delivering this high quality outcome. Our focus now, and over the next four years, is to deliver Council Plan 2017-27.

Other notable items

Upgrade of Gasworks Theatre completed

In June the upgrade to Gasworks Theatre building was completed. The building upgrade included works to improve acoustic and technical equipment, upgrade back-of-house facilities and accessible public toilet facilities, and replace the existing Graham Street portico and non-compliant ramp with a vibrant and accessible public entrance. The building upgrade process began in July 2014 to increase access and mobility and improve general amenity for users and patrons.

The first major exhibition in the upgraded space, involving schools and Inner South Community Health opened on 15 June. On 29 June the performance of 'Greek Goddess' with Maria Mercedes took place. The theatre will officially open 11 July.

Beach Street separated queuing lane commenced

Construction of the Beach Street queuing lane commenced on 5 June after the summer cruise ship season. The project will deliver improvements to the function of the roundabout at Beach Street and Waterfront Place by establishing a separated 'Station Pier' queuing lane for cruise ship and Spirit of Tasmania passengers.

Adventure playgrounds reopen

Skidders Adventure Playground and St Kilda Adventure Playground reopened in May after a responding to clean up requirements from the Environment Protection Authority (EPA). Regular attendees of each playground were transported to other parks to ensure minimal disruption to programming during the closure period.

Maternal and Child Health service turns 100

The City of Port Phillip provides a maternal and child health service to all families of the municipality. We have seven centres within our Council area to provide easy access for families. On 7 June we celebrated 100 years of providing the maternal and child health service to the residents of Victoria by opening a display of memorabilia and hosting morning tea at the St Kilda Town Hall.

Addressing safety concerns in Carlisle Street

Victoria Police held a Community Safety forum focussed on Carlisle Street, St Kilda on 13 June. We partnered with the Victorian Police in supporting the event to respond to the increasing concerns regarding behaviours associated with alcohol and other drug misuse in Carlisle Street, St Kilda.

Partnering to deliver improved health outcomes in our community

We have partnered with the cities of Melbourne and Stonnington to deliver 'What's Your Story?' an alcohol culture change initiative after being successful in applying for funding from VicHealth's Alcohol Culture Change Grants. These grants aim to improve cultures of risky drinking within subpopulations in Victoria. The 'What's Your Story?' program involves collecting and sharing stories of young adults with regard to alcohol culture. These stories will then be shared across the three municipalities.

Safer speed limits for our streets

Council is progressively reducing speed limits on local streets from 50km/h to 40km/h. Lower speed limits are safer for all road users, especially those most vulnerable, such as pedestrians and bike riders, children and older people.

South Melbourne Market Biggest Morning Tea

On 25 May the South Melbourne Market hosted its second annual Biggest Morning Tea. The market's involvement in the charity event began last year, when market cleaner Sandra White wanted to host a Biggest Morning Tea at her home. So many people

wanted to show their support for the event that she asked Food Hall traders and market management to help, and they raised over \$2,500. This year tickets sold out in 10 days and raised over \$8,000. Thirty two traders donated door prizes, food and volunteered their time to this fundraiser. Katherine Lane, Tameika Evans and Alissa Wilson from Cancer Council attended along with Mayor Bernadene Voss.

St Kilda Film Festival wraps up

On 27 May the St Kilda Film Festival wrapped up with the closing awards night, where filmmakers shared in more than \$50,000 in cash and in-kind prizes.

Welcome Home Allen was awarded the Best Short Film award and *The Khalik Family Kite* was awarded Best Documentary, both of which are now eligible for consideration for the 2018 Oscars.

The 2017 Film Festival was a great success, with increased attendance and glowing feedback from the film industry and audiences alike. Opening night is the largest industry gathering held annually and the festival is a key part of establishing our municipality as a filmmaking hub

From late June, highlights of the Film Festival will hit the road for the Regional Tour, funded by Film Victoria. Planning for the 35th annual festival is now underway.

Celebrating World Environment Day on 5 June

From 2 to 18 June the Acland Street Tram Terminus became a visual representation of sea life. Local artist Victor Holder created an interactive light display of Port Phillip Bay sea life that was projected onto the tram stop shade canopies. On opening night Acland

Street was brimming with life with live music, DJs, dancing mermaids and lots of family friendly fun.





Community requests responded to within agreed timeframes (Monthly)





Council Plan actions on track (Quarterly)





Community calls answered within 30 seconds (Monthly)













Council's year to date net emissions is 4,237 tCO₂e (tonnes carbon dioxide equivalent) which is below target. This quarter, gross emissions were 2,442 tCO₂e and net emissions (including carbon offsets) were 1,110 tCO₂e. Gross GHG emissions were 8% lower than the same quarter last year. The result is attributable to continued efforts to improve energy conservation in Council buildings, renewable energy installations and improving the efficiency of streetlights as well as a 'greening' of the national electricity grid.



Council used 27 ML of potable water between August and October 2016 bringing the year to date result to 145 ML (above target). The quarterly result is a 40 per cent decrease on the same time in 2015 and equates to a saving of \$64,000 compared to our water bill for the same quarter last year. The decrease is mainly due to high rainfall during the period which led to significant reductions in water usage at our parks and gardens (57 per cent reduction) and sports facilities (67 per cent).

Kerbside collection diverted from landfill (Monthly)







Council priority projects on track (Monthly)





(Monthly)





Financial performance – May 2017

Council's year to date cash surplus of \$16.7 million is \$3.7 million higher than the forecast year to date surplus of \$13.0 million. The key drivers for this favourable variance are summarised below:

Key variance explanations

Operating income - Year to date operating income is tracking marginally favourable compared to forecast by \$0.59 million.

Operating expenditure - Year to date operating expenditure is underspent by \$0.66 million compared to forecast mainly due to the following material items:

- ↑ \$0.77 million favourable Professional Services: partly due to the use of agency staff for delivery of operating projects (offset by increased employee costs) and delays in several operating projects, namely Business Enablement and Innovation fund, Strategic Parking Implementation, Fisherman's Bend Recast works, and Health and Safety Improvement project.
- ↓ \$0.37 million unfavourable Employee Costs: year to date expenditure greater than forecast due to the greater usage of agency staff instead of forecast spend in professional services.

Capital expenditure - Year to date capital expenditure is showing an underspend of \$2.52 million mainly due to the following material items:

- ⇒ Building Program \$0.62 million favourable: due to savings across a number of projects and delays with some key building projects expected to be completed in June including South Melbourne Market renewal works, Gasworks Building upgrade, and St Kilda Library air conditioner upgrade.
- ⇒ Plant and Equipment \$0.32 million favourable: mainly due to the parking ticket machine renewal project expected to be completed in June.
- ⇒ Roads \$0.94 million favourable: mainly due to savings and delays in progressing the Ross Street, Port Melbourne road renewal, road resurfacing program, Kendall Street, Elwood and Queens Lane upgrade.

Reserve Transfers - Year to date movement of reserves is a net replenishment of \$0.05 million, which is in line with forecast.

Project portfolio update - May 2017

The City of Port Phillip enterprise portfolio comprises over 140 projects with a total budget of over \$40 million. The table below outlines changes to the project portfolio during May 2017.

Project	Change
Council Depots Space Utilisation and Requirements Study	This project has been closed with a cost saving of \$9,200. Project was completed five months behind schedule due to the appointment of the Waste Program Director taking longer than expected.
Hardware and Software for Parking Infringement Issuing	This project has been closed showing an under spend of \$201,160. It was determined that parking hardware and software initiatives would be carried out by the Parking Technology Renewal and Upgrade Program in 2017/18 to produce a more holistic approach to parking in the municipality.
South Melbourne Market Solar Energy Project	This project has been closed as no design or construction work was completed in 2016/17 as a result of issues relating to building permits. A new project has been included in the 2017/18 Portfolio for design and delivery of the Solar PV System at South Melbourne Market. \$137,000 has been returned to the 2016/17 budget.
Trial of Parking Sensors and pay-by-phone	This project has been closed with no spend as the trial of parking sensors and pay-by-phone initiatives will be carried out by the Parking Technology Renewal and Upgrade Program in 2017/18 providing a more holistic approach to parking efficiency within the municipality.
St Kilda Triangle - Amendment C106	This project has been closed as it did not commence due to the Minister for Planning refusing an extension to the C106 Amendment. \$140,000 has been returned to the 2016/17 budget.
Port Melbourne Waterfront Place Precinct Design Guidelines	This project is reporting an under spend of \$35,325 for 2016/17 due to lower than expected costs. Completion date pushed out by 3 months to October 2017.
Arts Review Implementation of Recommendations 16 17	This project is reporting an under spend of \$20,000 due to lower than expected costs. Project completion has been pushed out by one month to 30 June 2017.
St Kilda Esplanade Market Renewal Project Stage 1	This project is reporting an under spend of \$7,143 due to some scope items, being delivered internally. The project closed eight months behind schedule on 7 May 2017.
Safe Roof Access	This project is reporting an under spend of \$32,739 due to safe roof access solutions at Sails on the Bay Restaurant being removed from the original project cope. These works will be undertaken as part of the Building Renewal Program in the 2017/18.
Linden Gallery Upgrade	Project is reporting a \$120,000 under spend for 2016/17 due to some works that were not completed. These works are now being carried over to the 2017/18 portfolio.
Repair of Beacon Cove Foreshore Promenade	This project is reporting an under spend of \$439,626 for 2016/17. \$350,000 has been included in 2017/18 under the Maritime Infrastructure Renewal program to complete this project. The project completion date has been revised to May 2018.

Road Renewal 2016-17	This project is reporting an underspend of \$140,000 due to the Jackson Street St Kilda Road reconstruction not being delivered in 2016/17 due to the proposed review of the one-way traffic flow in the street. Further internal consultation will be completed in 2017/18.
South Melbourne Market Water Installation	New project for 2016/17 to install water meters and a water monitoring and billing system to 73 stalls at South Melbourne Market at a cost of \$70,000.


