# Read before starting

It is important to note that a permit does not grant the applicant any exemption from current or future parking restrictions. All drivers must comply with parking restrictions and safety road rules.

Kerb charging permits enable an electric vehicle charging facility to be installed at the kerb by the nature strip in front of properties that have no off-street parking and are a standalone building (not apartments or units).

If your property does not comply with these two criteria, you are not eligible for a kerb charging permit.

Kerb charging facilities can only be used by residents of the address where the kerb charger is installed, and the permit holder is not able to make the charging service available to others.

The permit is currently on trial for up to 10 applicants. Please read the Electric Vehicle Kerb Charging Facility Trial Application Guidelines.

#### Fees

The fee for this permit is \$124, which covers on-site meeting, review and assessment of the application. A bond of minimum \$500 is payable as part of application fee.

An annual fee of \$100 is also required to keep the permit active.
