Message from the CEO

Welcome to the July CEO Report, which includes an update on the priorities that Council has set for me.

Deliver the Council Plan

Overall project portfolio delivery status for July is 71 per cent on-track progressing as planned, and 16 per cent at-risk.

In July, the Moubray Street Community Park project was completed and opened to the public. This space provides improved pedestrian connections in the area and offers active recreation with a climbing hit-up wall and netball half court installed on-site.

We also completed the St Kilda West Beach Boardwalk Accessibility upgrade which opened to the public. This marks a significant improvement in public infrastructure and a boost for safety and accessibility.

In July, we invited community feedback on draft concept plans for the St Kilda Adventure Playground redevelopment. This involved an innovative approach to engaging children in the design. This project is on-track with a final concept plan issued for endorsement by councillors.

Earlier in June, we endorsed our first Fair Access in Sport Policy and Action Plan to support women and girls' participation in sport. We launched this newly endorsed Policy and Action Plan at our Celebrating Women in Sport breakfast on 14 June, which came thanks to Change Our Game's Community Activation Grants program.

Governance and Advocacy

We continue to progress our work on the upcoming Council Elections, being held by postal vote in October. Our Council partnered with the Municipal Association of Victoria (MAV) to host a Stand for Council session at the St Kilda Town Hall on 31 July.

I attended this event alongside CEOs and other representatives from the City of Melbourne, Stonnington, Yarra, Glen Eira, Boroondara, and Bayside Councils. It was a great opportunity for potential candidates to hear directly from Council officers about what is involved in being a Councillor and how to be effective in the role.

In the advocacy space, we have sought transitional support for organisations providing food relief within the municipality, as well advocated for improved internet connectivity at Fishermans Bend, and greater support for water projects and opportunities in the Elster Creek Catchment.

Our engagement with our advocacy partners, including M9 was extensive. We helped organise

and attended meetings with Victorian Ministers
Harriet Shing (Housing and Water) and Sonia
Kilkenny (Planning), as well as Federal Minister Bill
Shorten do discuss planning, housing, and other
local government affairs. Through M9, we have
led advocacy for the process of delayed Planning
Scheme Amendments, and we contributed to the
National Urban Policy. Community, Stakeholder,
and Customer

For July, 94 per cent of community complaints were resolved within agreed timeframes, exceeding the target of 80 per cent and the result of the previous year (44 per cent for July 2023).

In July, 87 per cent of community service requests were resolved within agreed timeframes. This result surpassed the 80 per cent target as well as performance for the same time last year (86 per cent for July 2023).

In July 2,754 individuals visited the Have Your Say website and we received 182 contributions to our projects. The following projects were open for community consultation Edwards Park toilets upgrade, Reviewing and renewing the Danks Street Biolink, and Draft skatepark design in Port Melbourne.

Finance, assets, and value for money

As of 31 July 2024, the full year forecast for 2024/25 is a cumulative cash surplus of \$0.6 million which is \$0.02 million lower than Budget for 2024/25 due to a small reduction in the opening cash surplus balance.

The forecast as of July was updated to include project deferrals processed at year end after the adoption of the budget for 2024/25.

We continue to have an overall low risk rating using the Victorian Auditor General's Office (VAGO) financial sustainability indicators, a forecasted positive net operating result of \$9.9 million (3.7 per cent of total revenue).

The City of Port Phillip successfully applied for a Living Libraries grant for the Middle Park Activation Project. The project was announced by the Minister for Local Government, The Hon Melissa Horne in July. The funding, with a cocontribution from council, will be used for the library space to be redesigned in collaboration with our community, with a focus on ensuring it meets the needs of young people during the day. The redesign will also create more opportunities for events including primary school visits, book club meetings, author talks and after-school spaces.

Culture and capability

Staff turnover in July was 11.5 per cent from which is under the 15 per cent target. We're pleased to see that staff turnover has been trending positively downward over the last 12 months. With the Aged Care transition, we expect to see an increase in coming months but will report results with and without this impact.

In July, the percentage of occupational health and safety incidents reporting within 24 hours was 75 per cent which is below the 80 per cent target. Additional communications are being undertaken to understand any issues and remind staff and leaders of the importance of immediate reporting of incidents.

Celebrating women in sport in Port Phillip

In June, we endorsed our first Fair Access in Sport Policy and Action Plan to support women and girls' participation in sport. This Policy was created in response to the Fair Access Policy 'Roadmap' developed by the Office for Women in Sport and Recreation, in partnership with Sport and Recreation Victoria and VicHealth.

Using Change Our Game's Community Activation Grants program, Council hosted a breakfast on Friday 14 June to celebrate the local sport community as well as the launch of the newly endorsed Fair Access in Sport Policy.

The breakfast panel discussion was hosted by Change Our Game ambassador Rana Hussain, and featured AFLW player and professional boxer, Tayla Harris, former WNBL and AFLW player and Women Sport Australia board member, Chantella Perera, and local sports club leaders, Megan Drysdale (President of Middle Park Football Club) and Annette Maloney (President of Port Melbourne Colts Junior Football Club).

Panellists shared their experiences in sport and highlighted the importance of fair access for women and girls.

The event concluded with an opportunity for attendees to spend some time networking and meeting each other; with the opportunity to learn more about the great achievements occurring across our various sporting codes.

Attendees included local sports clubs, State Sporting Associations, community health partners, Councillors, City of Port Phillip staff and representatives from the Office for Women in Sport and Recreation.

Housing Support Program Grant

In August, we secured a \$350k grant from the Federal Housing Support Program to implement key actions under our Housing Strategy. The grant will fund technical work for a residential zone review which is expected to be completed by the end of August 2025.

The Housing Strategy, endorsed by Council on August 7, is our 15-year strategy outlining the housing Vision, Residential Development Framework Plan and Preferred Neighbourhood Character Statements to guide the growth and change of the future housing in Port Phillip. Aged Care services transition update

The transition of in-home care support services to non-for-profit providers continues as planned for 30 August. Most clients have transitioned, with some clients now receiving support through these newly appointed providers.

We have implemented a contingency workforce to ensure continuity of care is provided for a small number of clients who will not receive their first service until later in September. The contingency workforce will deliver services to ensure continuity of service prior to the first visit by their service provider. The implementation of the Village model continues as planned.

Parents groups for families with multiple children

In July the Maternal and Child Health Team trialled a parents group aimed at families who have more than one child and are seeking to connect with other parents in the municipality. During the COVID-19 pandemic, many families missed out on their first time parents' groups as groups did not run during this time.

To accommodate demand, a group trial for parents with multiple children was created and facilitated by our Early Parenting Practitioner.

The group was offered as a two-session meeting. Thirteen families attended the first session 10 families attended the second session.

The next session is booked for August 27th and currently we have 18 families on our waitlist.

Supporting children not engaging with school

School attendance rates in Australia have been declining over the past decade, with many children missing school. Experts prefer the term "school can't," highlighting that it's often not a deliberate choice by the child.

To address this issue, Family Services and other organisations are collaborating to understand and respond to the challenges. This included attending professional development and working groups, and a forum organised by the Child and Family Services Bayside Peninsula Alliance to share strategies for re-engaging students. Partners and practitioners included the Department of Education's School Attendance Support Program, the School Refusal Clinic, and Can't Face School, a consultancy that advocates for parents who have a child struggling to attend school.

They emphasise the importance of early intervention, identifying issues like mental health, anxiety, and bullying. Collaboration between schools and parents is crucial, along with positive communication to support the child. The Family, Youth and Children department aims to bridge the gap for students struggling to attend school, aligning with Council's Child Safe and Children's Services policies.

St Kilda Playgroup celebrates new members and new playground

Community playgroups uniquely contribute to community wellbeing and capacity building. St Kilda Playgroup, based at Bubup Nairm Family and Children's Centre, is one of these important groups and celebrated several recent milestones with a winter wonderland party.

The celebration saw children and families from 16 playgroups rugged-up and enjoying the newly re-opened playground.

St Kilda Playgroup welcomed newly created playgroups, including Jewish-Russian, Tiny Explorers (2 to 3 years old) and Crawlers and Up (6 months to toddlers) groups. The turnout of families highlighted the importance of the space to the community and having safe, flexible, accessible spaces for children of all ages to play and explore.

Number of direct hours of housing assistance supporting older local people (cumulative year to date)



The number of direct hours of housing assistance for July 2024 was 43 hours. The monthly target for this measure is 65 hours per month. The hours for July did not meet target due to a staff vacancy in this area in the second half of July.

Number of older local persons housed (cumulative year to date)



For July 2024, the number of older persons housed was six against a monthly target of five. The result varies depending on the availability of social housing properties.

Liveable Port Phillip

A City that is a place to live, where our community has access to high quality public spaces, development and growth are well-managed, and it is safer and easy to connect and travel within.

Moubray Street Community Park upgrade complete

The Moubray Street Community Park project, located in Albert Park has reached practical completion, and is now open to the public.

The project improved the open space experience by removing the road surface, providing improved pedestrian connections, retention of boundary fencing to the park and improving landscape amenity with a shelter, picnic tables seating and public art. Active recreation has been improved on site with a climbing hit-up wall and netball half court. In addition, the upgrade has increased greening with garden bed planting, tree planting and increased permeability.

The project was fully funded by Department of Energy, Environment and Climate Action (DEECA) from their Local Parks Program.

St Kilda West Beach boardwalk accessibility upgrade

We completed the St Kilda West Beach Boardwalk Accessibility upgrade which is now open to the public. The upgrade marks a significant improvement in public infrastructure, fostering inclusivity and safety. This project, part of the Public Space Accessibility Improvement Program, has focused on ensuring that the boardwalk is accessible to everyone, including those who use wheelchairs, prams, or other mobility aids.

The main objective of the project was provision of a Disability Discrimination Act (DDA) compliant connection from the foreshore paths to the existing West Beach boardwalk. The enhancements include a new ramp and boardwalk connection from Pier Road, additional seating made from recycled plastic, upgraded staircases with handrails to meet current standards, and the installation of new native vegetation garden beds.

These improvements not only enhance the functionality and safety of the boardwalk but also contribute to the aesthetic and environmental value of the area, making it a more inviting space for residents and visitors to enjoy the picturesque views of St Kilda West Beach.

The project was partially funded by Local Roads and Community Infrastructure (LRCI) federal government funding.

The EcoCentre has undertaken a community planting day on Saturday 27 July 2024 to complete planting works and celebrate National Tree Day.



For July, there were 41 fines issued related to animal management. Most of these infringements are for failing to renew registration. Renewals are due by 10 April each year, and after a follow-up process, infringements are issued for those who do not renew.

Percentage of collected animals reclaimed and rehomed (year to date)




Of the 11 animals collected from 1 July 2024 to 31 July 2044, five animals (45.45%) were reclaimed by their owners. Out of the remaining six animals, one animal was rehomed (16.66%). A further four (66.66%) animals were being assessed at the time this report was generated. All avenues are explored to ensure animals find new homes.

Port Phillip joins 'Solar Savers'

City of Port Phillip has joined the Solar Savers program to give residents, renters and businesses access to quality solar power systems, batteries, heat pump hot water systems, solar hot water systems and split air conditioning systems. Solar Savers is a local government program with 19 participating Victorian Local Governments.

The program supports residents and businesses through the process of upgrading to solar by understanding their needs, connecting them to accredited installers, offering competitive deals and providing support to apply for rebates, discounts and interest-free loans. The program offers the community the peace of mind that comes with knowing installers have been independently evaluated on their safety, product quality and value.

Port Phillip joins CitySwitch

City of Port Phillip has joined the CitySwitch program in 2024/25. CitySwitch is a greenhouse gas emission reduction program for office-based businesses in the City of Port Phillip.

CitySwitch was established in 2005 and provides resources and events to help office-based organisations to both calculate and reduce emissions. In July 2024, the program boasted 213 members (744 office tenancies) representing around 10% of Australia's total office space.

Through our direct participation in this program, we aim to support and encourage office-based businesses within our municipality to:


- reduce their carbon emissions



Percentage kerbside collection waste diverted from landfill




In July 2024, 38.6 per cent of kerbside collection waste was diverted from landfill which is just shy of the 40 per cent target however an improvement compared to the same time last year at 30 per cent.

Kerbside missed bins have been trending positively closer to target in recent months settling at 9.75 missed collections per 10,000 bins in July against a benchmark of less than five. The improvement trend is continuing since the significant issues of last July.

Percentage of investment in fossil-free institutions



Investment in fossil-free investment for July was 74 per cent, which is above a 60 per cent target. The percentage of investment in fossil-free institutions has been relatively stable over the past year and consistently above the target.

Vibrant Port Phillip

A flourishing economy, where our community and local businesses thrive, and we maintain and enhance our reputation as one of Melbourne's cultural and creative hubs.

HerStory Exhibition

The HerStory map, created earlier this year, highlights places in Port Phillip where women are commemorated in street names, parks, buildings, and public artworks. As part of the 'Put Her Name on It' initiative in Victoria, HerStory celebrates recognised women and addresses the historical gender imbalance in place-naming and commemoration.

The HerStory exhibition, which opened in July at Carlisle St. Art Space, explores the stories behind these women through images, artworks, and objects from the Port Phillip Collection and local historical societies.

The exhibition invites viewers to share their own stories of local women for future commemoration opportunities. The opening night of the exhibition was a fantastic celebration of the women and their stories, with many family members and community related to these women in attendance. The exhibition runs until 20 September.

During this period Council has also created an interactive online version of the map HerStory (tlcloud.com), which enables the map to evolve as more women are commemorated in our municipality. The online map is easy to use and links photos and information about the women and their contribution to our community.





Visits to South Melbourne Market






In July, the Safety and Wellbeing team continued with the delivery of key initiatives:





Percentage of Councillor requests resolved within agreed timeframe




In July, 91 per cent of councillor requests were resolved within agreed timeframes compared to 84 per cent for the same time last year. This is against a target of 80 per cent.

Percentage of community complaints resolved within agreed timeframes





Percentage of community requests resolved within agreed timeframes





Percentage of Council decisions made at meetings closed to the public




A total of 26 decisions were made at meetings held in July 2024. Of these, six decisions were made in a meeting that was closed to the public.

Percentage of occupational health and safety incidents reported within 24 hours (cumulative)





Financial report

As of 31 July 2024, the full year cash surplus forecast for 2024/25 was \$0.6 million which \$0.02 million lower than Budget for 2024/25 due to a small reduction in the opening cash surplus balance. The forecast as of July was updated to include project deferrals processed at year end after the adoption of the budget for 2024/25. Project deferrals do not change Council's cumulative cash surplus, however, change the timing of delivery of the projects. The net movement in project deferrals resulted from a mix of projects with some project completed ahead of schedule and brought forward and others deferred in 2024/25.

Ongoing high inflation continues to drive up the cost of delivering Council services. While the 2024/25 budget accounted for a 3.4 per cent inflation rate, actual inflation in Melbourne as of June 2024 was 3.67 per cent. This higher than anticipated inflation is putting additional strain on Council's Budget 2024/25.
