

### Message from the CEO

Welcome to the January CEO Report, which includes an update on the priorities that Council has set for me.

### **Deliver the Council Plan**

The overall project portfolio delivery status for January shows 67 per cent of projects are ontrack, progressing as planned, 18 per cent are atrisk, and 15 per cent off-track. January saw a decrease in the number of projects reported ontrack with a commensurate increase in the number reported at-risk. Across the portfolio, atrisk projects are the focus of intervention to bring them back on track. In January, we completed Stage 2 of the Elwood Foreshore Lighting Replacement project, replacing ageing infrastructure with new energy-efficient lights along the footpaths and cycle paths. This upgrade enhances lighting in the area, which in turn supports community safety.

Community safety is a priority for our Council with continued delivery of our holistic response to support the vulnerable in our community while managing local amenity and work with police to address anti-social and criminal behaviour. To address increasing concerns around crime and safety, Council is convening a Community Safety Roundtable in March for key local stakeholders, including Victoria Police and social welfare, health and housing service providers. Participants will discuss how we can work better together in addressing community safety concerns with a report to be considered by our Council in May. This work will also help inform our new Community Safety Plan. We will be providing a range of opportunities for members of our community to provide their feedback and insights on this complex topic during extensive community engagement. In the interim, Council has increased resources for our local laws amenity officers to enable twice daily patrols, year-round and we are working closely with Police and support agencies to address hot spots across the City.

#### **Governance and Advocacy**

Both of our submissions to the Australian Government's Thriving Suburbs funding program were successful, securing \$2.6 million for the St Kilda Pier Foreshore Upgrade. This funding will facilitate the next stage of works to extend the pier, foreshore, and promenade to connect with Jacka Boulevard. We also secured \$1.02 million for our St Kilda Adventure Playground Upgrade, supporting our plans to make the playground more accessible and better suited for our community's needs.

Our Advocacy team will soon launch Council's federal election <u>advocacy campaign</u>. We're

meeting with candidates to share our Federal Priority Project Opportunities booklet to help secure positive outcomes for the City of Port Phillip. We continue to engage with peak bodies such as the Municipal Association of Victoria on collective advocacy items of national significance. We plan to communicate with stakeholders, including the public and media, to highlight our key projects to ensure our advocacy efforts are visible and well-understood.

#### Community, Stakeholder, and Customer

Council is proud to be a major funding partner for the Midsumma Festival. On 28 January, we raised the progress pride flag over St Kilda Town Hall to celebrate our LGBTIQA+ community and reinforce our commitment for Port Phillip to be an inclusive city for all. This event was a precursor to the 30<sup>th</sup> anniversary of the Midsumma Pride March on 2 February, where an estimated 50,000 people marched down Fitzroy Street, St Kilda in solidarity with the LGBTIQA+ community.

The Boonwurrung Land and Sea Council, in partnership with our Council, hosted the annual We-Akon Dilinja (Mourning Reflection) ceremony on 26 January at Alfred Square, St Kilda. More than 500 people attended this dawn ceremony, recognising the journey and experiences of our local First Peoples. Now in its sixth year, this event is a very important part of Port Phillip's commitment to reconciliation.

A key initiative for the month was establishing a Community Panel for deliberation on the Plan for Port Phillip. A total of 40 people from a broad cross-section of the community were appointed to the panel and will take part in a series of workshops to provide their feedback on this important strategic plan.

In January, 89 per cent of community complaints were resolved within agreed timeframes, exceeding our target of 80 per cent. Pleasingly we saw a significant drop in complaints compared to this time last year. Similarly, 85 per cent of community service requests were resolved within agreed timeframes, surpassing our 80 per cent target despite an increase in requests compared to this time last year driven by hard and green waste collection bookings, graffiti removal requests, and tree pruning requests.

We are focussing on improving our call quality as we know our ASSIST call centre and counter services act as important connections to our community, taking 5,000 to 7,000 calls each month. Strengthening our focus on the call quality experience meant that we achieved a higher rate of first contact resolution, with at least 39 per cent of callers having their enquiry resolved at the time of their call, as well as a 94 per cent positive feedback rating from customers visiting our ASSIST counters.

#### Finance, assets, and value for money

At the end of January 2025, the full year cash surplus forecast for 2024/25 was \$1.46 million which was 0.84 million higher than the 2024/25Budget. This month the forecast was updated to reflect additional revenue generated by higher volumes of paid parking and parking infringements due to consistent summer weather as well as greater South Melbourne Market stall occupancy. The forecast was also updated to include mid-year budget requests including additional city amenity patrols, Sandridge Recreation Precinct masterplan works, bringing forward a review into the local law provisions of caravan and other vehicle parking, and enhanced resourcing for open space and tree maintenance procurement.

The Clever Port Phillip program continues to drive efficiency and productivity through digital transformation and streamlined workflows. Key initiatives, including the digitisation of Animal Management Patrol, City Amenity Patrol, and Councillor Forms, saved more than 1,825 staff days annually, reduced manual processes, and enhanced user experience. Additionally, automation improvements in our occupational health and safety system, Donesafe, has streamlined approvals and incident reporting. These efforts collectively enhance operational efficiency, mitigate risks, and support innovation in service delivery. We have also identified efficiencies through a reduction of external legal advice required for planning related issues by resolving matters internally, and the investment in more efficient street lighting will reduce power usage and lighting maintenance expense. These initiatives will result in savings of \$110,000 and \$180,000 for the Budget 2025/2026, respectively.

We continue to maintain an overall low risk rating using the Victorian Auditor General's Office financial sustainability indicators.

#### **Culture and capability**

Staff turnover for January was 17.2 per cent, which was above the 15 per cent target due to recent Australian Government aged care reforms and the transition of some of our in-home services to other providers. Voluntary turnover was 12.5 per cent and is slightly higher than usual but typical for the new year period when resignations tend to peak.

In January, the percentage of occupational health and safety incidents reporting within 24 hours was 96 per cent, which is the highest compliance rate for the year-to-date. This is also above the 75-80 per cent target range and is tracking at 85 per cent year-to-date.

Unfortunately, we have seen a recent spike in workplace violence and abuse incidents across some of our community facing teams. This includes a 57 per cent increase in incidents for our Safety and Amenity teams from the same time last year. Whilst we have several existing risk mitigation controls in place, further focused risk assessments have been conducted with relevant teams currently assessing further staff support. This includes scenario-based training and an increased frequency of de-escalation training for officers, alcohol and other drugs awareness training for officers, additional wellbeing check-ins for staff through specialists' external providers to support with vicarious trauma and fatigue due to frequent occupational violence exposure. We're also exploring options with our existing body cameras, such as the ability to access duress functions to obtain a quicker response from emergency services.


The program strengthens community connections and allows storytellers to share their cultural heritage.

Number of people actively sleeping rough (monthly data)


Data for this measure is provided by Launch Housing. During January, there were 38 people sleeping rough in our community (including in squats and vehicles) which is one more than last month. Council continues to support a coordinated response to rough sleeping. This involves a range of Council services and partnering with community organisations.



### Number of older local persons housed (cumulative year to date)

For January 2024, the number of older persons housed was seven against a monthly target of five bringing the year-to-date figure to 47. This is more than the same time last year where 44 older persons were housed. Several housing vacancies were available through Council's sponsorship housing agreement with Housing Victoria, which enabled these housing outcomes.

Our sponsorship housing pathway is solely for public housing estates for persons over the age of 50 or 45 for First Nations Identified. We redirect clients outside this age to other support services including Launch Housing with whom we have a funding deed arrangement – and other providers whom we work closely with including the Better Health Network and Sacred Heart mission.



### **Customer Housing and Homelessness Requests Answered**

This month, we introduced a new indicator that tracks the volume of homelessness and housing-related requests received by our team. In some cases, individuals can be housed through Council's Sponsorship Housing Pathway for older persons or via the Port Phillip Zero network.

Council plays a key role in facilitating connections with state-based and other partner organisations including Launch Housing, Better Health Network and Sacred Heart mission amongst others. These complex queries are mostly in relation to rough sleeping and seeking information about social housing. Tracking the full outcome of each enquiry is challenging, as referrals are made to multiple partner organisations.

This indicator reflects the number of enquiries we receive, and we strive to ensure each one is triaged within 30 days. In January, 100% of enquiries met this service level target.

Next month we aim to include data from the Port Phillip Zero Network to provide greater insight into the outcomes of some of these interactions.

# Severe heatwave response assists vulnerable community members

In preparation for summer, the Heatwave Sub Plan was updated in December 2024 and activated on 30 January 2025 ahead of the severe heatwave from 1–4 February. Council teams and community agencies worked together to keep residents informed and prepared to keep cool during this period.

A city-wide awareness campaign shared heat safety tips across libraries, community centres, childcare facilities and online platforms. Libraries extended their hours as designated cool spaces, and a free transport bus helped residents access these facilities. Over 726 Linking Neighbours members received direct updates.

The community responded positively, with many using the cool spaces and transport services. Emergency calls remained low, showing the effectiveness of these initiatives. Thanks to everyone's efforts, Port Phillip stayed safe and supported during the extreme heat!



### **Grants Update**

Council has successfully secured funding through the Commonwealth Government's Thriving Suburbs grant program for key community development projects:

 \$2,606,459 will be allocated to the St Kilda Foreshore Project, which involves extending St Kilda Pier to Jacka Boulevard, enhancing the area to create a world-class visitor experience and improve public access to this iconic location.  \$1,026,237 will support the St Kilda Adventure Playground Project, which aims to deliver upgraded safety features and amenities, fostering an environment that promotes healthy childhood development. This initiative will serve the growing communities of St Kilda and surrounding inner suburbs, benefiting future generations.

# Spa safety: residents prosecuted for failing to comply with barrier regulations

The Building Department has successfully prosecuted two residents from Kerferd Road Albert Park for failing to install a safety barrier around their outdoor spa.

In Victoria, all swimming pools and spas capable of containing water to a depth greater than 30cm must have a compliant safety barrier to restrict access by young children under the age of five, regardless of whether children live at the property. For the last three years, Council had sought compliance from the Kerferd Road residents, to obtain a building permit and to install a safety barrier around the spa.

While prosecuting residents is not the preferred option, the Court found that Council had acted reasonably in seeking compliance to install the required safety barrier and provided the residents sufficient opportunity to comply.

Each resident was found guilty of the criminal offense and was fined \$2,000 and collectively ordered to reimburse \$22,000 in Council's legal costs.

There were fifty-three kittens available for adoption, all under 6 months of age – desexed, microchipped and vaccinated.


Of the fifty-three kittens for adoption forty-one found homes on the day. A further six people returned to the shelter the next morning to adopt kittens they saw at the event but needed some time to think about it. This brings the total to forty-seven adoptions as a result of the event.




#### Number of fines issued related to animal management

For January, there were 66 fines issued related to animal management. Animal Management has increased the number of patrols in our parks and beaches over the summer period. Dogs are prohibited on some beaches and infringements are issued for this offence.

#### Percentage of collected animals reclaimed and rehomed (year to date)

Of the 93 animals collected from 1 July 2024 to 31 January 2025, 44 animals (47.31%) were reclaimed by their owners. Out of the remaining 49 animals, 14 animals were rehomed (28.57%). A further 10 animals (20.41%) out of the remaining (49) were being assessed at the time this report was generated. All avenues are explored to ensure animals find new homes. 17 out of the 93 animals collected were surrendered by their owners (18.28%).

Council received nine sealed local road requests in January which within the monthly threshold target of target 11 requests per month. Year-to-date, there have been 74 sealed road maintenance request which is below the 77 target. These requests relate to road, kerb and laneway condition.

About this project: Council has developed a masterplan for Elwood Foreshore to ensure that it meets the demands of our growing and changing community and is in the process of implementing the plan. We know that many of the buildings are ageing, that climate change might impact this area in coming years, that there are challenges for the way traffic and people move about the site, and that there are growing numbers of females in organised sports that we need to plan for. This initiative aims to address to implement the endorsed masterplan, over the next decade.	Detailed planning continues for the staged delivery of the masterplan. Recent work has focused on co-ordination with Melbourne Water's Elwood Main Drain Duplication Project which will have a considerable impact on the southern area of the reserve. Where possible, Council and Melbourne Water will coordinate reinstatement works to reduce impact, speed up delivery of the masterplan vision in these areas and benefit from economies of scale. To enable this coordination, detailed design has commenced for the upgrading of the reserve frontage along Head Street, including liaison with City of Bayside. A sustainable future, where our environmentally aware and active community benefits from living in a bayside city that is greener, cooler, cleaner, and climate resilient.

### **Elwood Foreshore Lighting Upgrade**

Stage 2 of the Elwood Foreshore Lighting Replacement project has now been completed. Existing aged lights, including some legacy assets that were handed over to Council, between Point Ormond Carpark and Elwood Angling Club have been replaced with new energy efficient lights along both the footpath and cycle paths along the Elwood Foreshore, to match those previously replaced in stage 1 of the project (Elwood Canal to Point Ormond). The project has included the installation of 42 poles along the foreshore.

These new lights are compliant with Australian Standards providing a well-lit area promoting public safety in this area. Council has adhered to the Department of Energy, Environment and Climate Action (DEECA) requirements minimising light spill, ensuring natural flora and fauna found along the foreshore are not adversely impacted.

Kerbside bin collection requests dropped slightly in January to 19.4 requests against a monthly threshold of 25 per 1,000 households. This is a good improvement compared to last year at 26.27 requests per 1,000 households.

In January, 41.2 per cent of kerbside collection waste was diverted from landfill which meets the monthly target of 40 percent Year-to-date, waste diverted from landfill is averaging 40 per cent compared to 35 per cent for the same period last year and reflects the roll-out of the municipal wide food-organics and garden-organics (FOGO) service.



### Kerbside missed bins were steady in January with 12.95 missed collections per 10,000 bins against a benchmark of less than five. The improvement trend remains steady however not at target expectations. Council continues to work with the contractor on improving performance and will soon be undertaking a competitive tendering process. Council is reviewing the target as part of the development of the new Council Plan & Budget.

### Plastic-free takeaway at South Melbourne Market

South Melbourne Market has made significant changes to reduce the environmental impact of its operation over the years. To continue being a leader in environmental sustainability, one of the three key strategic priorities identified in their 2023-27 Environmental Sustainability Strategy is to wipe out waste.

Since launching the Strategy in 2023, the Market has phased out unnecessary and avoidable single-use plastics, including produce and net bags at fruit & veg stalls, expanded polystyrene produce trays and decorative balloons. Last year, the Market commenced phasing out single-use plastic takeaway containers and are pleased to now see traders including Mama Tran Dumpling, Dragon Room Chinese and popular Vietnamese stall, Ba Ba Rolls, providing their takeaway offering in plastic free packaging. While consumers are always encouraged to BYO reusable containers for their takeaway lunch, those that forget can now find their favourite salads, dumplings, noodles and sandwiches in non-plastic alternatives, diverting this waste away from landfill.





### Visits to South Melbourne Market




During January, there were 431, 167 visits to South Melbourne Market. This was a decrease of 16,355 visits (3.65 per cent) compared to the same time last year and short of the 450,000 monthly target. The Market was busy proving popular with interstate and international visitors in Melbourne for the school holidays, cricket, and tennis. Visitation was impacted by some severe weather events, including high heat days, one day of severe storms and local flash flooding.

The street cleaning audits resumed in January. The street cleaning audit compliance score for January was 96 per cent against a monthly target of 90 per cent. This is a slight uplift in performance from last year at 95 per cent.

### Visits to libraries\*



There were 41,781 visits to our libraries in January which is a 9 per cent (3,458) increase compared to December and a 6 per cent increase compared to the same time last year (39,465 visits). The monthly target for visitation is 45,000. Year to date, visitation is on track at 321,151 visits made to libraries this financial year against a target of 320,833.

### **Engagement report**



In January, we offered a scaled back community engagement program

during summer holidays. Two projects were open for feedback:

- Reinvigorating Shopping on Acland St, St ٠ Kilda.

A key initiative during January was working to establish a Community Panel for deliberation on the Plan for Port Phillip. A total of 40 people from a broad cross-section of the community were appointed to the Panel and will meet during February at a series of workshops.

### Safety and wellbeing report

In January, the Safety and Wellbeing team continued with the delivery of key initiatives:

- The annual safety plan initiatives progressed with an injury management audit completed as well as a review of the implementation of the driving risk assessment controls.
- Safety incident investigations were completed on several significant incidents; actions and learnings relating to these investigations are progressing and being monitored.
- Desktop review currently being completed of the safety management system documentation.

### **Governance report**

The Council's Governance team has been working closely with councillors to ensure full compliance with all legislated onboarding requirements and mandatory training modules. This collaborative effort includes regular check-ins to track progress and address any potential gaps in knowledge, ensuring that all councillors are fully prepared to meet their responsibilities.

### Advocacy update

The advocacy team has been preparing for the launch of Council's federal election advocacy campaign. This has involved engaging with candidates towards achieving outcomes for the City of Port Phillip via meetings and letters; drafting and circulating a Federal Priority Project Opportunities document; and engaging with peak bodies such as the Municipal Association of Victoria on collective advocacy items of national significance.

A dedicated communications plan will allow for clear and consistent messaging about Council's efforts on behalf of the community. This plan will include strategies for effectively communicating with the public, stakeholders, and media to highlight the Council's key projects and initiatives. By utilising various communication channels such as social media, media releases, and newsletters, Council will ensure that its advocacy efforts are visible and well-understood.

### **Customer experience update**

Our ASSIST call centre and counter services are an important way for the community to connect with us and we take between 5,000 and 7,000 calls a month and see about 600-900 visitors a month at our ASSIST counters. The call centre takes enquiries for all services that the Council delivers and is focused on providing great service and quality responses to enquiries. We are getting good results through focusing on quality, with a strong and consistent first contact resolution of 39% in January, this means we are answering queries for customers without needing to log a request for service to another department or transfer the call. We have also been working toward improving our speed of answer for calls, we have noticed a pattern where we often see a surge in calls at 8.30am and 4.30pm, in response to these surges we have adjusted staffing levels where we can match the higher number of calls.

We have a continuous improvement approach with our website to supporting better useability and content that meets the needs of the community. In recent months, we have been implementing an upgrade to our website, this is expected to be complete in March and will ensure that we maintain strong security, and improve website performance, in terms of speed, mobility and improving the overall ease of use. We have a feedback form on our website that helps us to understand where we need to improve both information and the way our website works for the community, we are always pleased to receive feedback and update action improvements where we can.

We are in the early stages of improving the Parking and Transport community request category, this is aimed at making it easier for the community to identify and log specific enquiries or issues and streamline the back end, reducing time to triage and improving time to resolution.



Percentage of community complaints resolved within agreed timeframes




Percentage of community requests resolved within agreed timeframes




Percentage of Councillor requests resolved within agreed timeframe

### Percentage of Councillor attendance at council meetings\*





Percentage of Council decisions made at meetings closed to the public




Consequences range from a moderate breach that may result in a fine or suspension of a licence or permit to an extreme breach potentially punishable by imprisonment or action taken in High Court.

### **Portfolio Changes**

Beacon Road Active Transport Safety Upgrade project	This Beacon Road project involves developing a detailed design and construction of safe cycling infrastructure along Beacon Road. The new infrastructure will integrate with the proposed pedestrian-operated signal on Williamstown Road, which will be delivered by the Department of Transport and Planning (DTP), a project Council successfully advocated for, as well as connect to the recently completed Garden City Bike Path.
	The total project cost is estimated at \$1,030,000. The \$515,000 grant requires a 50:50 co-contribution from Council and the Federal Government. Councils' contribution will be considered as part of the 2025/26 Council Budget Process. Any Council contribution will be funded through Council's Sustainable Transport Reserve, a fund established to support transport projects.

### **Financial report**

As of 31 January 2025, the full year cash surplus forecast for 2024/25 was \$1.46 million which was \$0.84 million higher than Budget 2024/25. This month the forecast was updated to reflect additional revenue generated by higher volumes of paid parking, parking infringements due to consistent summer weather and greater South Melbourne Market stall utilisation. The forecast was also updated to include mid-year budget requests including additional city amenity patrols, Sandridge Recreation Precinct masterplan works, review into the local law provisions of caravan and other vehicle parking and open space and tree maintenance procurement.

In prior months, the forecast was also updated to include additional resourcing cost pressures and maintenance requirements for the ANZAC station precinct, electrical line clearance and emergency preparedness, parental leave and service delivery challenges in the aged care village model. These cost pressures were offset by efficiency savings achieved, additional rental income and higher volumes of parking infringement issued

There were also other movements that did not impact the cash surplus including an increase in forecast depreciation, additional developer open space contributions (held in reserve for future capital delivery) and a small reduction in net waste charge income through lower property growth (offset by the waste charge reserve).

At the start of the year, the opening forecast was also updated to include project deferrals processed at year end after the adoption of the budget for 2024/25. Project deferrals do not change Council's cumulative cash surplus, however, change the timing of delivery of the projects. The net movement in project deferrals resulted from a mix of projects with some project completed ahead of schedule and brought forward and others deferred to 2024/25.

### Key Financial Updates and Indicators:

- A forecast cumulative cash surplus balance of \$1.46 million noting ongoing risk of changing economic conditions and inflationary pressures. Persistent inflation continues to increase the cost of delivering core council services. This is particularly relevant to delivery of capital works.
  - Overall low risk rating using the Victorian Auditor General's Office (VAGO) financial sustainability indicators.
- Forecasted net operating result of \$10.6 million (4 per cent of total revenue).
- A working capital ratio of 273 per cent, noting that this is dependent on delivery of a significant capital works program over the next year.
- Working towards a target of \$1.8 million efficiency savings for Budget 2025/26. Noting efficiency savings are becoming increasingly hard to achieve.
- The cash and Investment balanced decreased to \$93.7 million (\$87.7m December 2024).
  - Council offers support for ratepayers who are suffering extreme financial hardship. This year rates waivers totalling \$3,047 (6 waivers) have been issued. This is in addition to waivers totalling \$4,407 (10 waivers) issued in the prior year.
