Welcome

Welcome to the first issue of the CEO Report for the 2016/17 financial year. In this issue we report the progress of the Council Plan delivery, now in its final year. We also cover activities which improve the value for community and an update on Council's priority projects.

Delivering the Council Plan

Fishermans Bend Urban Renewal Area

Heritage Controls

The Amendment CI17 FBURA Heritage Controls aims to apply the Heritage Overlay to 16 properties in Fishermans Bend and update the Port Phillip Heritage Review to reflect new and revised heritage citations and gradings. The Minister for Planning has appointed an independent Planning Panel and the hearing of submissions is scheduled for 10 to 11 August and 9 September.

Fishermans Bend Community Infrastructure Plan

Consultation on existing community services was undertaken from 19 May to 19 June. More than 200 surveys replies were received. The outcomes of the survey will be used to inform Council's understanding of current and future community infrastructure needs. It will also inform the Fishermans Bend Community Infrastructure Plan.

Ferrars Street Education and Community Precinct

Detailed design for the South Melbourne Ferrars Street Primary School is nearing completion. The tender process commenced in late August upon completion of public realm design. Community consultation for the proposed Planning Scheme Amendment process to create Montague Community Park, including a Road Closure Overlay which will close sections of the surrounding roads to maximise the park, closed on 22 July. Formal submissions were presented at a Council Meeting on 9 August, with officer recommendations presented at the Council Meeting on 23 August.

St Kilda Triangle

In July officers drafted the Design Guidelines for the St Kilda Triangle. Community consultation on the Design Guidelines is anticipated to commence early 2017, with a Planning Scheme amendment to follow. This will give effect to the Masterplan and deliver on community's aspirations.

During July, Council officers reviewed responses to the Expressions of Interest (EOI) for a winter event on the St Kilda Triangle. The outcome of the EOI process was published on the website in August.

Palais Theatre

Following the announcement on 11 July of Live Nation as the new operator of the Palais Theatre, Council has been working with Live Nation to ensure a smooth transition to the new lease in April 2017 (subject to completion of current building works). Bookings for the Palais Theatre for 2017 can now be made online at http://www.portphillip.vic.gov.au/palais-theatre.htm

Internal and external repair works to the theatre are continuing on schedule around the operations of the theatre and are expected to finish in February 2017.

Vibrant places and villages

Throughout July officers collated results of the third intercept survey conducted in June to give a time series 'snapshot' view of our villages.

Also in July, Council welcomed new members who responded to Council's Expression of Interest for the Village Partnership Groups (VPGs). The program purchased a projector in conjunction with Council's Arts team. This will enable visual space activations across the municipality and support local visual artists to have their work publicly displayed. This purchase will result in a saving for Council through the reduction of equipment hire costs.

Toward Zero implementation

Council endorsed the Car Share Policy 2016-2021 on 26 July. The Car Share Policy addresses the escalating transport problem in the City by providing a range of convenient, safe and sustainable travel options for our community. The endorsed policy supports the provision of peer-to-peer car share and has set ambitious targets for member numbers (from 4,000 to 11,200) and number of the car share bays (from 79 to 330) by 2021.

Community consultation results showed 97 per cent of respondents supported the car share policy to help decrease car ownership and emissions, help the environment and provide access to a car when they wanted it. Consultation results and findings are available on Council's website at

On 19 July, over 100 people attended a double feature film night where local marine documentaries 'Baykeepers' and 'Melbourne Down Under' were screened at Elwood College. The event, organised by Year 9 Elwood College Students with support from Love Our Street 3184 and Council, was designed to inspire action to prevent pollution flowing to Port Phillip Bay.

On 23 July, Council endorsed the commitment to become a founding partner of the Victorian Government's TAKE2 Pledge. The TAKE2 Pledge is Victoria's collective change initiative and community awareness program to help Victoria reach zero net greenhouse gas emissions by 2050 and keep global temperature rise below two degrees.

Gasworks Arts Park remediation

The Department of Treasury and Finance's (DTF) Independent Auditor signed off on an investigation approach for Gasworks Arts Park. The investigation approach document will be released to the community prior to any further onsite investigation. The approach follows the Environmental Protection Agency (EPA) guidelines for conducting a human health assessment (s53x). To view the s53x process, head to the EPA's website:

St Kilda Life Saving Club

There have been several delays in the project caused by technical and weather impacts. The revised completion date is October 2016.

During July the concrete panels, structural steel and roof were installed. Construction will continue in August with works to include external cladding and internal framing.

South Melbourne Life Saving Club

Development of the detailed design continued in July in accordance with Council's endorsement of concept design on 24 May.

Council will continue to engage with the South Melbourne Life Saving Club and Life Saving Victoria to ensure the design is a fit-for-purpose facility.

JL Murphy Reserve sport pavilion

During July, user groups provided feedback on an alternate design for JL Murphy Reserve. Council officers have been working with the architect to incorporate the feedback, where possible.

Further discussions will be held with the user groups throughout August and September to finalise concept design.

Peanut Farm Reserve sport pavilion

Based on community consultation conducted in June, Council officers developed the concept design, for presentation at the 23 August Council Meeting. Subject to endorsement by Council at this meeting, work on the detailed design will commence. Queens Lane precinct

During July, Council officers assessed community feedback for the preferred traffic management option as part of the consultation process in June. St Kilda Road safety improvement project

VicRoads briefed Councillors on the proposed community engagement and communications process. On 26 July, Council provided in-principle support for the project and endorsed VicRoads' proposed objectives and design principles.

Affordable Housing Strategy

During the month Council officers met with the three local community housing organisations, housing experts and other organisations to receive advice on the proposed trust model.

Improving community value

Continuous service and business improvement

In July Council improved service delivery for parents with children in Council-run childcare centres. This was achieved through communication and billing information being provided electronically to parents instead of in hard copy formats. This saves over 13,000 sheets of paper per year, decreases staff administration time, and provides more immediate communications to parents.

Enterprise portfolio management

In July work was undertaken to support Council's end of financial year reporting processes and close out the 2015/16 project portfolio. Project sponsors and project managers have been working to establish the 2016/17 project portfolio in line with the Council's endorsed budget.

Capability development has continued to be a focus for 2016/17. We are also implementing changes to support more streamlined processes, which will shift some capacity from compliance assurance to capability building.

Aligned organisational culture and capability

In July Council refined its Employee Plan and Performance Review process and templates, resulting in an automated process that is simpler, more streamlined, increases alignment to Council objectives and improves staff performance.

Good governance

After the endorsement of the new Councillor Code of Conduct on 28 June, all Councillors declared and signed the Councillor Code of Conduct in July. The endorsement of the Councillor Code of Conduct shows Council's commitment to good governance practices and compliance with legislation requirements.

Also during July, Council began the second review of the Local Government Act. The initial review was submitted to the Victorian Government in December 2015, with the second due in September 2016. Over the month preparations have advanced for the Council election, the caretaker period and a support program for the newly elected Council.

Other notable items

Neighbourhood parking consultation

In response to community feedback, Council has developed a strategic approach to parking. This approach aims to balance the need for parking restrictions with community's needs in an effort to minimise parking impacts on the liveability of our community. Community consultation on the proposed parking changes in St Kilda closed in July. Officers are reviewing feedback and will communicate any amendments to the community. The final plan for parking changes for St Kilda is expected in September.

The parking change review of Albert Park, Middle Park and St Kilda West is nearing completion, with sign installation to commence in August. Further information can be found at http://www.portphillip.vic.gov.au/parkingneighbourhood-apmpsk.htm

Safer speed limits for our community

The roll out of reduced speed limits continued during July in St Kilda East, South Melbourne, parts of Port Melbourne and the St Kilda Road precinct. Mandela Day celebrated in St Kilda

During the month Council celebrated 'Mandela Day' with a tree planting ceremony. Nelson Mandela International Day is an annual event held on 16 July. 'Mandela Day' is a global call to action celebrating the idea that each individual has the power to transform the world, and the ability to make an impact. The City of Port Phillip was the first council in Australia to plant a tree in honour of Nelson Mandela. The event was initiated by Cr Jane Touzeau, with Cr Serge Thomann, after they attended the inaugural Nelson Mandela oration at Parliament House at the end of May. Cr Touzeau organised the event with the Friends of the St Kilda Botanical Gardens. Cr Serge Thomann represented Council and planted a Queensland Cape Chestnut at St Kilda Botanical Gardens alongside Ray Sithole, Acting High Commissioner (South African High Commission); Peter Uzande, of the organising committee for Nelson Mandela Day and the community.

City of Port Phillip opens their doors

On 30 and 31 July ten sites across the city opened their doors as part of the fifth annual Open House Melbourne. The Esplanade Vaults, built as shop fronts in 1891 were a big drawcard. The ten properties opened as part of the initiative were:

Open House Melbourne began in 2008 as a means to connect people with good design and architecture in the city. The annual free weekend involved a series of accessible, informative and entertaining talks, tours, and workshops.

As part of the weekend, two free events were held within the City, the first with David Willis, author of "The Majestic: Early Apartment Living in St Kilda" to explore the development of flat living in St Kilda. The second event was 'Making the most of what you've got: a conversation with heritage and sustainability experts from the City of Port Phillip'.

Team collaboration a success for families

Council's Maternal and Child Health and Family Youth and Children services collaborated with Launch Housing to develop a playgroup for families in transitional housing in the City. A Maternal and Child Health nurse and immunisation team visits the playgroup to perform key age and stage development checks and offer catch-up immunisation services.

White Ribbon ambassadors

On 16 July, a lunchtime speakers forum on family violence was held, presented by Council's White Ribbon ambassadors. The White Ribbon ambassadors are a voluntary team of men from across Council who have taken the oath to stand up, speak out and act to prevent men's violence against women. The forum featured author Ruth Clare who spoke candidly about her childhood experiences and the impact of a violent father. The forum progressed Council's commitment to work towards a community culture where all women and children are protected from violence. Audience members received first hand insight into the pain caused by family violence and the need for Council to continue the necessary dialogue to influence change.

Construction on the foreshore

Councillors and staff inspected the construction progress of two iconic buildings on our foreshore – the St Kilda Life Saving Club and the new Stokehouse. Both buildings are on track to be opened in Spring ready for summer in St Kilda. Innovative building practices and materials in both buildings show a commitment to sustainability and resilience to extreme weather conditions. I want to thank staff who have worked with the operators, community members, government departments and other key stakeholders to see these projects progressed for our community's benefit.
