Brief background:	New licences have been negotiated with Albert Park College for the above property addresses.
	Albert Park College has its main campus located at 83 Danks Street and a secondary site at 62 Pickles Street, both in close proximity to Gasworks Arts Park and Lemnos Square.
	Access to Gasworks Arts Park is unrestricted and open to the public including Albert Park College that has been using the park during school hours (lunch time, etc.) for a long time now.
	The community has raised some concerns that the use of the school conflicts with other users of the park.
	Albert Park College does not have any agreement in place with Council supporting its use.
	Consequently, Albert Park College has requested that Council formally allows its use of the park (including Lemnos Square) through licence agreements.
	A report recommending granting of these licences was presented, heard and approved by Council at its meeting on 18 March 2020.
	Council at its meeting on 18 March 2020 endorsed the recommendation subject to the following conditions:
	 Each of the licence prohibits sporting games or the use of sporting equipment.
	 Each of the licence requires appropriate public liability insurance to be in place.
	 Each of the licence includes requirements for the school to reimburse Council for any maintenance works required due to school use.
	 The licence (for the Gasworks site) stipulates that the public amenities within the Gasworks Theatre and Café complex are not to be utilised by the school.
	Each of the licence has an end date of no later than 31 December 2020.
