ANAM is a world-class and unique institution. Despite its limitations SMTH has successfully operated as its home for many years, and I have attend many wonderful concerts and events there. The refurbished building will become a matching world-class home for it in the future. ANAM's plans for the building are very well thought through. I can't think of a better use for the building. 1 ANAM proved itself over many years to be an asset to the community of Port Phillip while a resident of the South Melbourne Town Hall in past years. It has been a mutual benefit to the young musicians and also the local community who have had privileged access to membership of ANAM and their performances. 1 ANAM has been sadly missed while repairs have been done. I see this as a unique opportunity for Council to ensure the viability of this significant asset by appointing ANAM as a committed lessee to manage its future use and development. Who else has shown up to love and develop this asset and contribute to the surrounding community to enrich it culturally and financially. ANAM has shown itself to be reliable and committed and to contribute to a new generation of the country's most talented young musicians. 1 1 I don't think the entire Town Hall building should be leased. Surely some rooms can be reserved for local community use. The Town Hall is much loved, and important to the identity of local people. 1 We are leaving the arts behind in this country. Plenty of money to go around for sport, betting and mining companies, but we are not lifting up the arts like we should. ANAM has been a jewel (both nationally and internationally) for Port Phillip, and the proposal means that it will return to Port Phillip. However, and very importantly it will ensure the upkeep and maintenance of the Town Hall (which will then not be a burden on ratepayers to preserve the building). and will provide spaces for a range of arts and related activities that is not available at the moment. 1 Previously ANAM's presence has brought people into the locality and has been good for businesses and animating this area. Since CoPP built their offices at St.Kilda Townhall and moved their business there the SM Townhall has not been available to the residents. In the past, ANAM have offered very cheap concerts to the residents which are a great bonus to the cultural diversity of Sth.Melbourne. Also, it is a lovely addition to the community mix to see young musicians in the surrounding streets and cafes, a bonus to local businesses as well. I kiss the youth and multi cultural aspect too. 1 I think ANAM are a perfect fit for this large building and they are willing to pay a rent and keep it in good shape. 1 The people of South Melbourne community's building should not be tied to ANAM - it is South Melbourne's building. Whilst preserving the building's heritage character, a full restoration of the Town Hall by ANAM will realise its rich 21st century potential. This project is designed to provide new energy and a revitalised community focus to the Emerald Hill precinct. This investment will: Upgrade the 350-seat Main Hall's heating and cooling, operational infrastructure and public amenity; Unveil an intimate new public performance space — the 150-seat Supper Room — in the 1st floor west wing, with an external terrace; Include a welcoming café that will enable anyone to spend time in the Town Hall; Deliver a new modern catering kitchen to service events in both the Main Hall and the Supper Room: Bring the building's services up to 21st century capability (fire, hydraulics, electricity, data, heating and cooling); Increase the Town Hall's energy efficiency, and introduce solar power, insulation and water recycling, aiming to deliver a carbon neutral building; Ensure that the architectural and civic heritage of the building is preserved and amplified, working closely with Council's Conservation Management Plan (Lovell Chen); Work with local First Nation's groups to ensure that the rich story of this place is brought into the foreground of the creative concept for the building and its environment; Feature external building lighting and projection, making it a beacon that draws the community toward it; Ensure that the front doors will once again be the Town Hall's main entry, with access to people of all abilities and mobilities. The project will generate jobs, economic and local hospitality growth, retail and tourism, while revitalising an important historic building at little cost to ratepayers, arresting the slow decline of a magnificent building and providing a one-off opportunity to redefine its potential for generations to come. 1 ANAM's program is not only wonderful for the future of classical music in Australia, but it also provides regular, top level affordable performances for its community. 1 Its plan focuses on access for everyone in the City of Port Phillip, not just its students. South Melbourne has a historical affiliation with the music industry which is important to continue & support. South Melbourne also needs economic activity to help support the Traders and the wider community. The proposed ANAM lease will contribute to activation and has certain commitments to community as part of this lease. It must be a condition of lease that these commitments at minimum are met for the duration of the new Lease. To further cement the intent of ANAM's Community commitments, the Clarendon & Coventry Streets Business Association (CCSBA) proposes that ANAM become an active member of the business community by:-1.Becoming a financial member of the Business Association, 2.Once re-established in South Melbourne, ANAM to have a representative on the CCSBA Committee 3. Support the CCSBA in economic activation events (as relevant), thus supporting the business community 4.Specifically, allow access for festivals/functions/events in the front of the Town Hall, grass area and car parks situated in front of the Town Hall 5.Allow the CCSBA to occasionally hold meetings in the Town Hall, particularly AGM's, and, 6. in refurbishment allowances of the Town Hall, to seriously consider structural avenues for reducing wind flows in front of the Town Hall to allow for better use of this forecourt. If the above commitments to our community and business community are met, the CCSBA, support the proposed lease. 1 The City of Port Phillip deserves to host the continuity of a performance based music center such as ANAM as a high caliber tertiary school of music, and the utilisation of the refurbished SMTH to house such as a performance focused community arts facility in Melbourne 1 I'm a regular attendee of ANAM's performances and would love to see them back at the Town Hall. The prospect of other arts events happening at the Town Hall is also just as exciting 1

 - is essential in ensuring the maintenance and development Australian culture and our contribution to culture around the world.
 - Supporting ANAM to remain based in the culture epicentre of Melbourne is of significant benefit to other institutions and organisations in Melbourne.
 - The Town Hall lost (previously while ANAM was in situ) it's civil function. The music academy only appeals to a narrow community sector.
 - 1 The condition & maintenance of the building declined over that period. I live beside the building & saw very few signs of ANAM informing the neighbourhood of events.
 - The South Mlebourne town hall is owned by the citizens of South Melbourne by subscription.
 - In this day and age when we are seeking to protect our history it is important not to lose it to the citizens of South Melbourne
 - The town hall should be open and be able to be used by its citizens whether it be Port Phillip or South Melbourne. The past has shown that many weddings and balls were held in the town hall until the amalgamation when it was stopped.
 - The demand for its use was curtailed and thereby lost to the community
 - although ANAM could use the venue it is not right for it to be at the exclusion of all others.
 - The history of the town hall is in every part of the building recognising the 2 wars, local artists which were all removed put into storage never to be seen again
 - The Current cost of repairs to the mansard and roof seem outragous owing to the fact that the South Melbourne Council spent some
 - 100s of thousands dollars on the mansards and the roof in the early 90s.
 - For ANAM to have total use of the town hall denies the citizens or any future groups or organizations to be able to use the town hall as it was able to in the past.
 - In allowing ANAM total control of the town hall means is is unavailable for any future community use.
 - As time has shown society has different demands as years progress meaning the town hall should be open to all in the future 1
 - I support a lease to ANAM which would contain provisions which would allow Port Phillip residents to access and utilize some parts of the Town Hall complex, including the main hall. for municipal business activities and public functions such as have been held there throughout the building's history.

 - The detail of such public utilization could certainly be negotiated with ANAM such that their activities would be largely unaffected.
 - A general overlay of timeslots available for both ANAM and the municipality would form part of the lease, with the proviso that both parties could negotiate variations in specific instances. 1
 - The Town Hall complex should NOT be leased unconditionally.
 - ANAM provides both the local community and music students with access to something special. Something not available anywhere else in Australia.
- Its location at the South Melbourne town hall is pivotal to its success for both parties.
- ANAM has been a good tenant for 25 years and there is no reason for this to change if it continues to lease the building, especially in view of the heavy investment it is making. For ANAM, the location of the building in close proximity to the CBD Southbank music venues and convenient to public transport provides an excellent venue for cultural training and performance. 1 The SMTH building is already a monument to grand culture, rather than to sit comfortably with Sth Melb's poorest locals:
 - let it be revamped and modernised to continue to celebrate the vibrant cultural institution that is ANAM, given the Lease will extend opportunities to other cultural groups.
- As long as social services and council admin has a welcoming home close by. 1
- 1 Encouraging local development in the arts can only add to our precinct. Utilising an existing space that suits this use makes perfect sense and provides valuable investment into our people and culture.
- 1 ANAM is a vital part of the Melbourne education and cultural scene, it offer a high level of training to it's students and offers amenity to the City of Port Phillip

There is undoubtedly a need to preserve SMTH for future generations, as part of our heritage, and for this to happen the building needs to be used. As heritage is cultural, there is no better use than an artistic/music place of learning. The opportunity does not come up often, so yes, let's grasp it. 1 Great use of a historical building for a good cause - culturally and for the community. 1 The proposed developments will return the South Melbourne Town Hall to its former glory as a cultural hub of Melbourne, which is hugely important to ANAM donors. 1 It is difficult to decide exactly what changes are to be made to the interior spaces (not a lot of detail provided) and what effect that would have on potential other local use of the town hall over the next 50 years. Who knows what the community will need over the next 50 years and if ANAM will stay the same, expand so that the town hall space is not longer viable, or even exist over the entirety of that period. With ANAM's practice and performance schedule being extensive it is difficult to see when other local community groups will be able to gain access to any part of the town hall. 1 I am hoping that the performance criteria that ANAM must meet in the lease is very specific and not just "spend 20.5 million dollars in upgrades". The town hall has been closed for repairs since we moved into the area in October 2022. It would certainly improve the vibrancy of the area to have ANAM in the hall - local cafes and restaurants would likely benefit from increased footfall. I'm not sure that using it for council purposes would enliven the area or mean it was fully utilised (and I am not aware of a viable proposal for this use existing). 1 ANAM has a proven record of successful management and performance events and as a cultural and learning body which has involved and enriched the local and wider community. 1 It will give new and continued life to a key building that is of great historical, social and cultural value to the local community while ensuring it will also serve the wider community of the whole of the region in which it is located. 1 To enable the restoration of the beautiful heritage building and bring life to it through performances and a cafe on site 1 art, music, creativity within our community enriches our lives. Providing long term support in offering a home & performance space for this highly regarded music school is a wonderful idea. Even if ANAM was a private music academy' displacing 'community value, lagree with the group's aims but, sadly, it has no demonstrated value in realising those aims. Public value requires outcomes, not just itemt. Appropriate uses of a heritage building should achieve a good fit between the spaces they require and the building they use. There are few other uses that would achieve such a good fit of need with opportunity as ANAM at the South Melbourne Town Hall. Most other possible uses will fit elsewhere; community group offices and meeting rooms don't need the type of accommodation offered by the Town Hall, and would waste a unique opportunity. Appropriate uses should reflect the site's significance. As its listing on the Victorian Heritage Register indicates, the site has more than local value. Few options for appropriate uses, the liability for the Council. The well-known costs of keeping old building are magnified here by heritage conservation controls and past neglect.
