## Message from the CEO

Welcome to the February CEO Report, which includes an update on the priorities that Council has set for me.

#### **Deliver the Council Plan**

The overall project portfolio delivery status for February shows that 70 per cent of projects are on-track, progressing as planned, while 17 per cent are at-risk, and 12 per cent off-track.

We announced respected legal and community leader, Ian Gray AM, as the chair of the Community Safety Roundtable held in March. As Chair, Ian led discussions with key stakeholders including Victoria Police, community legal services, health and housing providers, and social service organisations - asking what more our Council could do to enhance community safety. This involved identifying actions, collaborations, services gaps and opportunities to improve safety for all in our City. The conversations, ideas and submissions will inform lan's report, expected to be tabled at a Council Meeting in May. The Roundtable is one input to the new, wide-ranging Community Safety Plan our Council is developing. Formal community engagement will begin in late May, as we are eager to have to gather the community's views to help shape the Plan.

We hosted the annual St Kilda Festival on 15 – 16 February, attracting an estimated 350,000 visitors to our foreshore for a celebration of Australian music, summer and the St Kilda community. The Festival opened with 'First Peoples First', a day dedicated to First Peoples' music, dance, and culture. 'Big Festival Sunday' followed, showcasing St Kilda at its best with live music throughout the precinct including community groups, dance performances and activations on Acland and Fitzroy Streets to promote and showcase local businesses. We were pleased to secure financial support from the Victorian Government's Revive Live program and Creative Victoria's Community Support Fund to help deliver the Festival.

#### **Governance and Advocacy**

In February, we convened a community panel to provide additional advice and recommendations for the development of the Plan for Port Phillip. The panel met for 15 hours across four workshops where they discussed, negotiated and voted on their recommendations on the 10-year Community Vision and key priorities for the next four years.

We also launched our first community engagements for 2025, with two projects open for feedback: the St Kilda Library Uplift and the St Kilda Botanic Gardens Public Toilet. Additionally, we are pleased to report that all nine councillors have completed their mandatory induction training, including several online training modules.

#### Community, Stakeholder, and Customer

For February, 89 per cent of community complaints were resolved within agreed timeframes, exceeding the 80 per cent target. This result is consistent with our performance during the same period last year. We saw a 15 per cent reduction in complaint volumes compared to January and a 23 per cent reduction in complaint volumes compared to February 2024.

We resolved 87 per cent of community service requests within agreed timeframes in February, up from 85 per cent in January. This result surpassed the 85 per cent target and matched the performance from the same time last year. This achievement comes despite a 2.5 per cent increase in requests compared to January, and an increase of 9.2 per cent compared to the same period in 2024. Despite these increases, we continue to perform well above the service level of 80 per cent.

#### Finance, assets, and value for money

At the end of February 2025, the full year forecast 2024/25 cash surplus was \$1.73 million which is \$1.1 million higher than the 2024/25 Budget. This updated forecast reflects additional income from an increased number of residential properties due to developments within the municipality, leading to a net increase in supplementary rates (increased population also increases costs to Council). This was partially offset a decline in utilisation of Council's long day care services, which has increased the cost of operating the services.

We continue to maintain an overall low risk rating using the Victorian Auditor General's Office financial sustainability indicators.

#### **Culture and capability**

We have seen an increase in rolling turnover over the past three months, primarily due to the impact of our exit from Aged Care services. However voluntary turnover remains within our target range at 12.8 per cent.

In February, the percentage of occupational health and safety incidents reporting within 24 hours was 91 per cent, with a year-to-date rolling figure of 86 per cent. This remains above the 75 -80 per cent target range.

#### Family Services supporting the Libraries Team at St Kilda Festival

This year, the Family Services Team collaborated with the Libraries Team for the first time at St Kilda Festival.

The teams came together with a shared commitment to supporting the community and families by providing access to essential resources and opportunities for children's wellbeing and development. This cross-team collaboration not only enhances future work opportunities but also helps us become more familiar with those who visit the library space while we meet with clients.

The Family Services Team used this opportunity to promote Council-run childcare centres and assist with registrations when needed. These conversations were insightful and clarified some misconceptions about waitlists and availability while gathering valuable feedback to share with our colleagues.

We also shared information about our programs and how we can offer support to families in our community. Many community members were unaware of our services, making this direct outreach a valuable opportunity to raise awareness and promote them effectively.

### Monthly service statistics



#### Number of people actively sleeping rough (monthly data)

Data for this measure is provided by Launch Housing. During February, there were 37 people sleeping rough in our community (including in squats and vehicles) which is one less than last month.

The number of people can fluctuate from month to month, with decreases related to individuals being housed in long-term secure, affordable housing. Other reasons for decreases include people are no longer eligible for inclusion on the Port Phillip list as they have relocated to a list in another local government area, not being seen for over 90 days, or no longer requiring housing (e.g., a long-term traveller living in a vehicle).

Council continues to support a coordinated response to rough sleeping. This involves a range of Council services and partnering with community organisations.

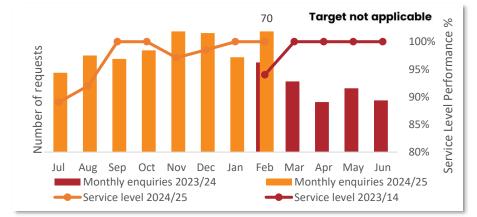


#### Number of older local persons housed (cumulative year to date)

For February, five public housing vacancies were filled through Council's sponsorship housing agreement with Housing Victoria. This brings the total number of older people housed to 52 against a year-to-date target of 40.

Our sponsorship housing pathway is solely for public housing estates for persons over the age of 50 (or 45 for First Nations Identified). We redirect clients outside this age to other support services including Launch Housing with whom we have a funding deed arrangement – and other providers whom we work closely with including the Better Health Network and Sacred Heart mission.

#### Customer housing and homelessness enquiries



This indicator reflects the number of housing and homelessness enquiries we receive. This month we received 70 enquiries related to homelessness and housing. In February, 100% of enquiries met the service level target.

Council plays a key role in facilitating connections with state-based and other partner organisations including Launch Housing, Better Health Network and Sacred Heart mission amongst others. These complex queries are mostly in relation to rough sleeping and seeking information about social housing. Tracking the full outcome of each enquiry is challenging, as referrals are made to multiple partner organisations.

#### Rough Sleepers Initiative monthly contacts and hours



This data is provided via Launch Housing, whom we partner with to deliver housing and homelessness support including provision of assertive outreach services, and general housing information and support. The data shows the number of individual contacts made and respective hours delivered in outreach services and is reported as trend data.

Assertive outreach workers made 247 contacts and delivered 133 hours directly working with those sleeping rough in February 2025. A reporting issue was identified with the hours reported late last year. This has since been rectified and will result in higher contact hours being reported from February. #### Community Safety Roundtable to be chaired by Ian Gray AM

The City of Port Phillip is pleased to announce that respected legal and community leader lan Gray AM will chair the upcoming Community Safety Roundtable in mid-March.

A long-time Port Phillip resident, Ian brings extensive experience in Iaw, justice, and community advocacy. He has served as Victoria's Chief Magistrate, a County Court Judge, and State Coroner, and was appointed a Member of the Order of Australia (AM) in 2021 for his significant contributions to Iaw and Indigenous justice. Currently, he is an Adjunct Professor at Victoria University.

lan's career has been defined by a strong commitment to social justice, having:

- Advocated for fairness in sentencing and
   Indigenous justice
- Led legal and community initiatives at state
   and national levels

- Served on the National Council for Aboriginal Reconciliation
- Contributed to legal reform and dispute resolution with the United Nations in East Timor

As Chair, Ian will lead discussions with key stakeholders – including Victoria Police, community legal services, health and housing providers, and social service organisations – to explore practical ways to improve safety in Port Phillip's high streets and public spaces.

What the Roundtable Aims to Achieve:

- Review best-practice community safety models from other cities
- ✓ Examine local laws and police protocols for protecting public spaces
- ✓ Assess the potential for an ongoing alliance to enhance safety over the next four years
- Provide short- and long-term recommendations to the Council

#### St Kilda Marina Redevelopment update

The redevelopment of St Kilda Marina has faced financial challenges due to rising construction costs and historic site contamination. The City of Port Phillip and Australian Marina Development Corporation (AMDC) continue working together to address these issues, including a costeffective contamination management plan.

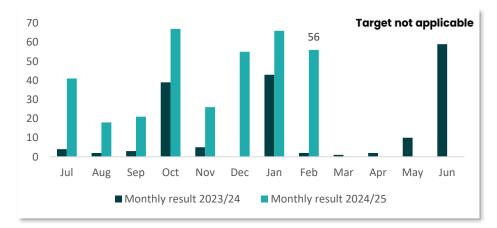

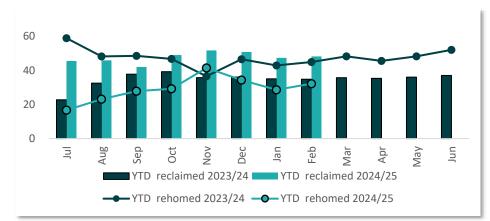


#### Number of fines issued related to animal management

For February, there were 56 fines issued related to animal management. Animal Management has increased the number of patrols in our parks and beaches over the summer period. Dogs are prohibited on some beaches and infringements are issued for this offence.

#### Percentage of collected animals reclaimed and rehomed (year to date)

Of the 108 animals collected from 1 July 2024 to 28 February 2025, 52 animals (48.15 per cent) were reclaimed by their owners. Out of the remaining 56 animals, 18 animals were rehomed (32.14 per cent). A further 9 animals (16.07 per cent) out of the remaining (56) were being assessed at the time this report was generated. All avenues are explored to ensure animals find new homes. 20 out of the 108 animals collected were surrendered by their owners (18.52 per cent).

Council received 11 sealed local road requests in February which is at the monthly threshold target of target 11 requests per month. Year-to-date, there have been 85 sealed road maintenance request which is below the 88threshold target. These requests relate to road, kerb and laneway condition.

#### Waste Strategy update

City of Port Phillip is preparing a new Waste and Recycling Strategy to guide how we manage waste in the coming years. This follows the delivery of *Don't Waste It! 2022–2025*, which introduced major service changes, including food and garden organics recycling and communal glass hubs.

With evolving legislation—such as the requirement for separate glass recycling by mid-2027—and the need to reduce landfill waste, the new strategy will focus on enhancing recycling services, minimising contamination, and supporting a circular economy. This approach ensures resources are reused, reducing environmental impact and long-term costs.

Council is also working to improve waste communication, making it easier for residents to stay informed about services and changes. Community feedback will play a key role in shaping the new strategy, with engagement opportunities available throughout March.

#### Staff clean up our own backyard

As part of Clean-Up Australia Day, on February 28, Council staff removed nearly 90 kilograms of waste from the streets surrounding the Operations Centre in South Melbourne. In one hour, the haul of litter included: 68kgs of general waste; 11kgs of e-waste; 6 kgs of scrap metal; 28 containers eligible for the 10c refund; vapes and approximately 500 cigarette butts. The clean-up is an annual event for staff.

Residents and traders are encouraged to visit Council's website for information on ways to appropriately dispose of waste and recycling.

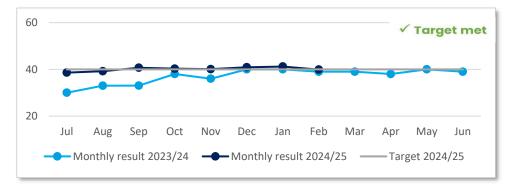
Kerbside bin collection requests (per 1,000 households)

Kerbside bin collection requests were 17.10 in February against a monthly threshold of 25 per 1,000 households. This result is on par to the same time last year at 17.27 requests per 1,000 households.



#### Kerbside collection bins missed (per 10,000 scheduled kerbside bin lifts)

Kerbside missed bins per 10,000 collections was 10.5 in February which was the lowest result since July 2024 (9.75 lifts missed). Council continues to work with the contractor on improving performance and will soon be undertaking a competitive tendering process. Council is reviewing the target as part of the development of the new Plan for Port Phillip (including Annual Budget).



#### Kerbside collection waste diverted from landfill

# In February 39.9 per cent of kerbside collection waste was diverted from landfill which meets the monthly target of 40 percent. Year-to-date, waste diverted from landfill is averaging 40 per cent compared to 36 per cent for the same period last year and reflects the roll-out of the municipal wide food-organics and garden-organics (FOGO) service.

#### Percentage of investment in fossil-free institutions



Fossil free investments in February were 61 per cent, meeting our target of 60 to 80 per cent. This target is at risk as this had trended downwards in recent months due to several factors. Overall funds invested have decreased due to settlement of property acquisitions. Additionally, market volatility due to inflation and RBA rate changes resulted in fossil free banks not taking investment funds. A merger in the banking sector further reduced green banking options for Council. Council continues to prioritise fossil free investments to meet our sustainability commitments, balancing this with managing risk and return. We continue to monitor this closely to seek green options and ensure we meet all our investment targets.

#### St Kilda Festival 2025

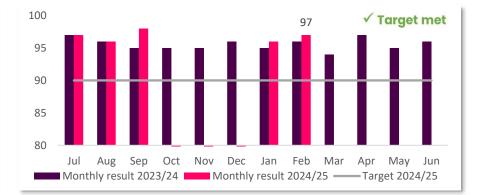

During February, there were 393,563 visits to South Melbourne Market. This was a decrease of 14,461 visits (3.5 per cent) compared to the same time last year and short of the 450,000 monthly target. During February, less than average visitation is expected in the shorter month. High heat days also impacted Market visits.

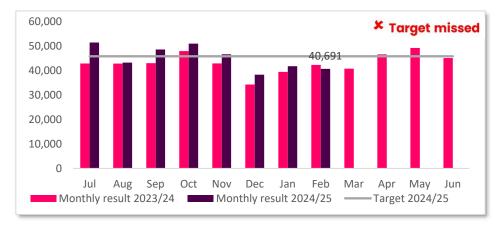
#### Per centage of street cleaning audit compliance



In February, the street cleaning audit compliance score 97 per cent against a monthly target of 90 per cent. This is a slight uplift in performance from last year at 96 per cent. Data for October to December was not available due to staffing issues and audits not taking place.

Council is currently reviewing the street audit framework to ensure that the quality of street cleaning meets community and trader expectations. The new framework will be finalised ahead of being used to audit and assess our performance from 2025/26.

#### Visits to libraries\*



There were 40,691 visits to our libraries in February which is a 3 per cent (1,090) decrease in visits compared to January and a 4 per cent decrease compared to the same time last year (42,308 visits). The monthly target for visitation is 45,000. A technical issue with the door counter at Emerald Hill Library has resulted in lower recorded visitations for that site, impacting overall visitation figures. The door counter has since been fixed.

Year to date, visitation is 1.3 per cent shy of the annual target (361,842 visits made against a target 366,66).

#### **Deliberation on the Plan for Port Phillip**

During February 2025, Council held a community panel to provide additional advice and recommendations about the Plan for Port Phillip. The panel consisted of approximately 40 community members from different walks of life. The panel met for 15 hours across four workshops to deliberate and form recommendations on the 10-year Community Vision and priorities for the next four years.

The panel was given the context to make informed decisions and recommendations; they

heard from Council Officers, received information packs, and considered a presentation from a futurist.

Through discussion, negotiation and voting, the panel members identified changes to the existing Community Vision as well as their seven top priority areas for the Port Phillip community over the next four years.

Panel Member feedback included:

"It was a unique and fulfilling opportunity, and I appreciated everyone's input and insights. I also learnt a lot about our beautiful city!"

"[I] needed to put my own bias and views aside and work to listen to other points of view and understand why they have been developed."

#### 2024 Councillor Mandatory Induction Training

The Local Government Amendment (Governance and Integrity) Act 2024 made various amendments to the Act that aim to enhance standards of governance and behaviour across the local government sector.

From 26 October 2024 all Mayors, Deputy Mayors, and Councillors must complete mandatory training within certain timeframes. The Regulations prescribe the matters that must be covered in the delivery of the mandatory training and the timelines for the completion of the training. The mandatory training includes:

- Mayoral training this must be completed by all Mayors, Acting Mayors (appointed for one month or more), and Deputy Mayors within one month of being elected to the role.
- Councillor induction training this must be completed by all Councillors within four months of taking the oath or affirmation of office.

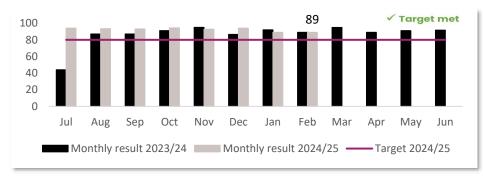
We are pleased to report that all nine City of Port Phillip Councillors have completed their mandatory induction training (including further six online mandatory training modules) as of 28 February 2025.

#### Digital and Technology Solutions Team Focus -OneCouncil Upgrade and Insights Reporting

The focus for DTS has been working on the upgrade of our Enterprise Resource Planning (ERP) system, OneCouncil, to its latest version of software which is due to go live on the 11th of March. In addition to the planning to support a successful ERP upgrade, the team have been working on the creation of dashboards, including the Infringements Dashboard, to provide our Business teams with greater insights into their business processes, empowering teams with data driven decision making and driving business process efficiency.

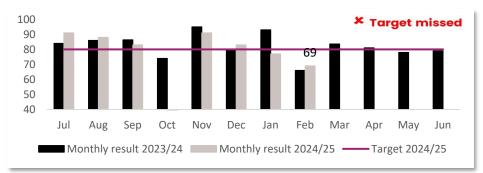

#### Percentage of community complaints resolved within agreed timeframes



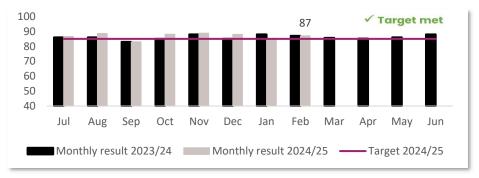
For February, 89 per cent of community complaints were resolved within agreed timeframes, exceeding the 80 per cent. This result is on par, to performance for the same time last year. There was a 15 per cent reduction in complaint volumes compared to January, and a 23 per cent reduction in complaint volumes compared to February 2024.

#### Percentage of Councillor requests resolved within agreed timeframe



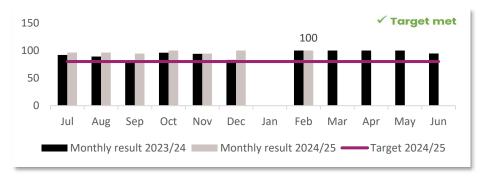
For February, Councillor requests resolved on time was 69 per cent which was below the 80 per cent target however three percentage points higher than last year (66 percent met service level). In February, there was a 13 per cent increase in Councillor Request volume compared to January, and service levels drop by 10 percentage points (77 to 69 percent in February). An increase in Councillor request volume aligns with the onboarding of new Councillors and an increase in information requests.

#### Percentage of community requests resolved within agreed timeframes

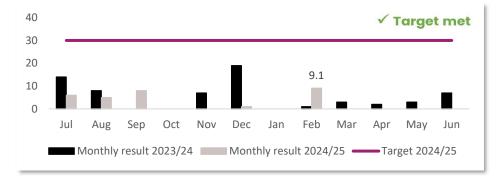


For February, 87 per cent of community service requests were resolved within agreed timeframes up from 85 per cent in January. This result surpassed the 85 per cent target and was on par to the same time last year. There was 2.5 per cent increase in request volume compared to January, and an increase of 9.2 per cent compared to the same period in 2024. Despite increases, we continue to perform well above the service level of 80 per cent.

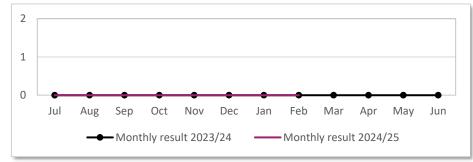

#### Number of material legislative breaches

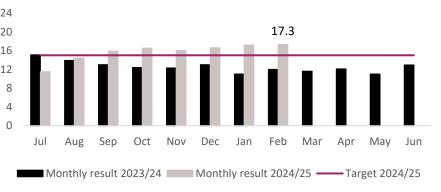


There were no material legislative breaches for February 2025. A material legislative breach is determined as a 'moderate to extreme' breach in our incident assessment criteria. To make an appropriate assessment we consider the financial, reputational and legal and regulatory consequences of the incident and apply the relevant rating.

Consequences range from a moderate breach that may result in a fine or suspension of a licence or permit to an extreme breach potentially punishable by imprisonment or action taken in High Court.



#### Staff turnover (rolling 12-month average)



In February, the percentage of occupational health and safety incidents reporting within 24 hours was 91 per cent for the month and with a year to date rolling figure of 86 per cent, which remains above the 75-80 per cent target range.

Rolling turnover continues to see an increase of the last three months with an increase of resignations and the flow on from Aged Care Exit. However Voluntary turnover remains within target at 12.8%.

## **Financial report**

As of 28 February 2025, the full year forecast 2024/25 cash surplus was \$1.73 million which was \$1.1 million higher than Budget 2024/25. This month the forecast was updated to reflect additional income through an increased number of residential properties from developments within the municipality resulting in net increase in supplementary rates (increasing population increases costs to Council). This was partially offset a decline in utilisation of Council's long day care services increasing the cost to Council of operating the services

In prior months, the forecast was also updated to include additional and maintenance requirements for the ANZAC station precinct, responded to legislative requirements through additional electrical line clearance, service delivery challenges in the aged care village model and additional organisational parental leave. Council has also responded to safety concerns in the community through funding additional resourcing for emergency preparedness and additional city amenity patrols. Additional temporary project funding has also been approved for the Sandridge Recreation Precinct masterplan works and open space and tree maintenance procurement.

These cost pressures were offset by efficiency savings achieved, additional rental income for commercial and South Melbourne Market leases, and higher volumes of parking infringement issued. There were also other movements that did not impact the cash surplus including an increase in forecast depreciation, additional developer open space contributions (held in reserve for future capital delivery) and a small reduction in net waste charge income through lower property growth (offset by the waste charge reserve).

At the start of the year, the opening forecast was also updated to include project deferrals processed at year end after the adoption of the budget for 2024/25. Project deferrals do not change Council's cumulative cash surplus, however, change the timing of delivery of the projects. The net movement in project deferrals resulted from a mix of projects with some project completed ahead of schedule and brought forward and others deferred to 2024/25.

#### Key Financial Updates and Indicators:

- A forecast cumulative cash surplus balance of \$1.73 million noting ongoing risk of changing economic conditions and inflationary pressures. Persistent inflation continues to increase the cost of delivering core council services. This is particularly relevant to delivery of capital works.
- Overall low risk rating using the Victorian Auditor General's Office (VAGO) financial sustainability indicators.
- Forecasted net operating result of \$11.8 million (4 per cent of total revenue).
- A working capital ratio of 270 per cent, noting that this is dependent on delivery of a significant capital works program over the next year.
- Working towards a target of \$1.8 million efficiency savings for Budget 2024/25. Noting efficiency savings are becoming increasingly hard to achieve.
- The cash and Investment balanced decreased to \$128.2 million (\$93.7m December 2024).
- Council offers support for ratepayers who are suffering extreme financial hardship. This year rates waivers totalling \$3,047 (6 waivers) have been issued. This is in addition to waivers totalling \$4,407 (10 waivers) issued in the prior year.
