# New Animal Registration

Pet registration is a legal requirement under the Domestic Animals Act 1994.

## What you need to do for your application

### Before you start!

The fast and easy way to apply is online via

Otherwise complete this form to apply in person.



### Complete the form

Make sure all sections are complete. Remember only microchipped animals can be registered.



### Bring supporting documents

To ensure we can process your application make sure you bring all applicable documentation.



### Receive your tag

We will issue a tag on the spot for in person applications, otherwise we will mail your pet's tag to you.

### Registration period

Registration period runs from 10 April to 9 April. Renewal is due on 10 April each year.

### Service dog free registration

Guide dog / customs dog certificate required.

### Transfer of registration

Provide receipt of your paid 2023/2024 registration from your former Council to transfer registration to the City of Port Phillip.

### Claiming 50 per cent state concession?

Provide a copy of a current concession card with your application.

### Free registration criteria

Your pet must be microchipped and registered within four (4) weeks of you taking ownership. Supporting documentation must be provided with your application, for example; invoice, adoption certificate/agreement, microchip change of ownership form that states date of purchase.

### State Government Levy

The State Government Levy of \$4.19 for dog and cat registration is used to help fund responsible pet ownership education programs.

### Restricted breed

From 1 November 2002, the Domestic Animals Act 1994 introduced specific restrictions for the keeping of Restricted Breed Dogs. State Government has made legislation to restrict the American Pit Bull Terrier, Pit Bull Terrier, Dogo Argentino, Japanese Tosa, Fila Brasileiro, Perro De Presa Canario.

### Desexing Cats

It is mandatory for all newly registered cats to be desexed. This does not apply to cats that are currently registered. Some exemptions apply, contact us for more information.

## Privacy policy

The personal information requested on this form is being collected by Port Phillip City Council to assist in the assessment of your animal registration application. The personal information will be used solely by Council for that primary purpose or directly related purposes. Council may disclose this information to VicRoads and Victoria Police. If this information is not collected, Council will be unable to process your application. The applicant understands that the personal information provided is for the assessment of the application and that he or she may apply to Council for access to and / or amendment of the information. Requests for access and / or amendment should be made to Council's Governance department.
