Present the outcomes of the St Kilda Triangle market sounding and feasibility study to the Victorian Government, including the outcomes of the community consultation, and request funding and resources within the 2024/25 budget to undertake a business case, with Council to contribute up to \$400k. State Government Business Case for Investment (State) Timeframe: 8 to 10 months commencing mid-2024. Detail the case for investment outlining the problem the proposal is solving and the benefits for government investment (State and Council) to support a contribution to the project in accordance with State Government business case protocols.
