## What you need to do



### Complete the form

Make sure all sections are complete and you have supplied all supporting documents.



### Submit application

This form and supporting documents must be submitted via email or by mail.



### Receive your invoice

Once your application is processed you will receive an invoice within five working days.

## Read before starting

A property information request provides a statement of information relating to the following sections of Building Regulations 51 (1), 51 (2) and 51 (3).

It is most frequently used when buying or selling property, or prior to modifying a property.

### Application fee

Each Certificate requested requires separate payment.

### Section 51 (1)

- A permit or certificate of final inspection issued in the last 10 years;
- Any current determination made under regulation 64(1) or exemption granted under regulation 231(2)
- Current notices or orders issued by the relevant building surveyor under the Act

### Section 51 (2)

Whether the building or land is:

- in an area that is liable to flooding within the meaning of regulation 5(2);
- in an area that is designated under regulation 150 as an area in which buildings are likely to be subject to attack by termites.
- Designated land or designated works.

### Section 51 (3)

The approved dates of the inspections carried out of the mandatory notification stages of building work carried out on the building or land. (Available for request by an owner or mortgagee of a building or land, or a prescribed building practitioner reporting on a building under section 137B of the Act).
